Overall **Port Focus** for 2024 and beyond

Port Update – August 2024

- Port continues to advance its three key priorities:
 - Maintenance and modernization of the ship channel
 - Building and maintaining infrastructure (docks, rail, warehouses, laydown yards)
 - Lease land for economic development
- Tonnage moved by customers through the waterway through seven months is 117.3 million tons, up 1% from first seven months of 2023
- Near term focus:
 - Completion of the Channel Improvement Project
 - Kickoff of 30 year dock maintenance and modernization
 - Modernization and enhancement of rail infrastructure
- Potential new industry development could require new dock construction, and potential deepening of La Quinta Channel




\$65 Billion Capital Investments (\$12 Billion Foreign Direct Investments)

2020 8 vessels 4,087 cargo



Al Speight Yard Rail and Drainage Modifications



- Work will result in construction of two new rail tracks within the yard
- Project scope includes pavement repairs and drainage modifications
- Al Speight Yard vital to military movement and equipment storage operations




Security Command and Control Center Remodel & Improvements


Key work components

- **First Floor:** Expanding bathrooms; hardening storefront/lobby and exterior door/windows; removing spiral staircase; and leveling atrium floor.
- **Second Floor:** Hardening an office and remodeling to include hallway for secondary staircase.
- Third Floor: Adding hallway for secondary staircase.
- **Other:** Complete roofing system composed of multi-ply SBS modified bitumen; additional exterior staircase; and additional interior staircase.
- Estimated Completion: August 2024 (Under Construction)






Ortiz Center Interior Improvements
