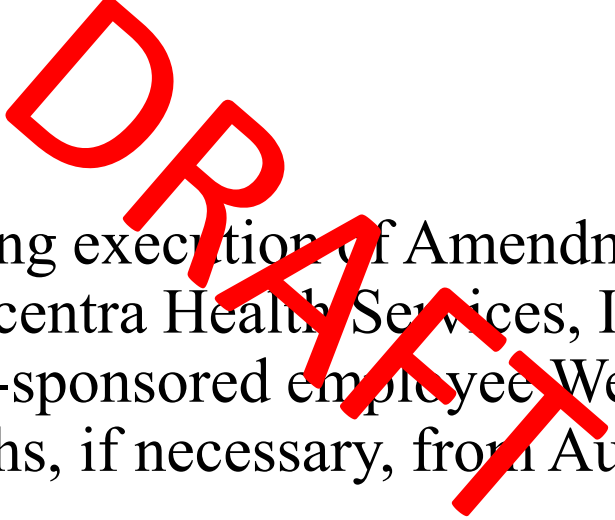


Concentra Health Services, Inc Service Agreement Amendment No. 2

Summary

- Resolution authorizing execution of Amendment No. 2 to the service agreement with Concentra Health Services, Inc., to continue providing services for the City-sponsored employee Wellness Clinic for up to an additional five months, if necessary, from August 1, 2026, through December 31, 2026.
 - Extending Service Agreement No. 3525 to a short month to month arrangement, to bridge primary care coverage to the City employees and dependents

Terms of Service Agreement No. 3525

- Initial term: 8/1/2021 – 7/31/2024
- 1st Option period: 8/1/2024 – 7/31/2025
- 2nd Option period: 8/1/2025 – 7/31/2026
- Compensation: Up to amount of \$4,598,999
- Expenses as of 7/31/2026: \$4,210,043
- Remaining on contract: \$388,956

 **SERVICE AGREEMENT NO. 3525**
Employer-Sponsored Wellness Clinic

THIS **Employer-Sponsored Wellness Clinic Agreement** ("Agreement") is entered into by and between the City of Corpus Christi, a Texas home-rule municipal corporation ("City") and Concentra Health Services, Inc., d/b/a Concentra Medical Centers, for the benefit of and on behalf of its subsidiaries, affiliates, and managed professional associations and corporations ("Contractor" or "Concentra"), effective upon execution by the City Manager or the City Manager's designee ("City Manager").

WHEREAS, Contractor has bid to provide management and operation of an employer-sponsored wellness clinic services in response to Request for Proposal No. 3525 ("RFP"), which RFP includes the required scope of work and all specifications and which RFP and the Contractor's bid or proposal response, as applicable, are incorporated by reference in this Agreement as Exhibits 1 and 2, respectively, as if each were fully set out here in its entirety.

NOW, THEREFORE, City and Contractor agree as follows:

1. **Scope.** Contractor will provide Employer-Sponsored Wellness Clinic ("Services") in accordance with the attached Scope of Work, as shown in Attachment A, the content of which is incorporated by reference into this Agreement as if fully set out here in its entirety, and in accordance with Exhibit 2.
2. **Term.**
 - (A) This Agreement is for three (3) years. The parties may mutually extend the term of this Agreement for up to two (2) additional one year periods ("Option Period(s)"), provided, the parties do so in writing prior to the expiration of the original term or the then-current Option Period.
 - (B) At the end of the Term of this Agreement or the final Option Period, the Agreement may, at the request of the City prior to expiration of the term or final Option Period, continue on a month-to-month basis for up to six months with compensation set based on the amount listed in Attachment B for the Term or the final Option Period. The Contractor may opt out of this continuing term by providing notice to the City at least 30 days prior to the expiration of the Term or final Option Period. During the month-to-month term, either Party may terminate the Agreement upon 30 days' written notice to the other Party.
3. **Compensation and Payment.** This Agreement is for an amount not to exceed \$4,598,999, subject to approved extensions and changes. Payment will be made
