2. [26-0336](#) Fuel Station Update - John Murray

Mr. Murray was not present to update the committee on the fuel station progress, but Mr. Atwood advised electrical installation is pending and all issues with the fire marshal have been worked out.

Mr. Dunlap did not have an update on grants.

Mr. Herrington did not have an update on safety and clean up.

Mr. Stokes did not have a marketing update but Mr. Atwood advised we are currently running ads on Facebook to attract transients for the 4th of July and tenants for the newly opened docks.

F. Director's Report

In his director's report, Mr. Atwood advised the marina office will be closed on Friday, June 19th for Juneteenth. The Mayor's Cup Regatta takes place on July 4th. Mr. Stokes advised the ILCA Championship was a huge success with many compliments on the marina docks. Ninety sailors from around the country came to Corpus Christi to compete in the sailing competition.

G. Unfinished Business

6. [25-0155](#) Capital Improvement Projects Update

In his CIP update Mr. Atwood advised the contractors working on the Coopers Alley boater's facility have driven 20 of 47 piles, some going down as far as 75 feet. The new estimated completion date is March 2027. The haul out and office construction project will go to council on June 23rd. Mr. Atwood and staff have already begun speaking with Council members to educate them on the project. The newest CIP is the dredging of the Peoples Street T-head with Type A funds remaining from the A, B, C, D, and L pier project. The RFQ went out and closed on June 1st, the selection process may take up to two months. This project will include dredging of the marina "gap" entrance.

Mr. Atwood advised HDR plans to finish the feasibility study of the breakwater at the end of May and would turn their report into the Engineering Department soon after. He will reach out to get a copy of the report for the marina.

Mr. Herrington advised he and Mr. Indrelunas spoke at the City Council meeting regarding boat washing during water curtailment. The mayor's motion to amend the Emergency Level 1 verbiage to add positive shut off valves on hoses and allow for the washing of boats and boat engines was approved. It will be up to marina staff to police water usage throughout the marina when we reach emergency level 1.
