Botanical Gardens

- Grant: \$89,000 approved by City Council on July 21, 2020
- Agreement was amended in June 2023 to extend completion date
- Complete Construction by March 31, 2024
- Received TPW Recreation Trails grant of \$200,000
- Firm selected to do survey





Del Mar College Process Technology II

- Addition to the Process Technology Plant
- Grant: \$2,356,000 approved by City Council in August 2018
- Grant paid: \$2,355,923
- Grant remaining: \$77
- Operational and should use all the grant funds
- They have 698 students enrolled and 284 have graduated
- Expires: 09/17/23







Next Sports Company

- Grant of \$1,850,000 was signed on October 23, 2020
- Agreement was amended January 23, 2021, to allow owners more time to complete financing of the project, complete construction by November 30, 2023
- Owner purchased an additional acreage adjacent to the site for parking and cleared land
- Working with Development Services to get permitting to start construction
- Amended June 2023 to extend construction completion to:
 - Phase I December 31, 2024
 - Phase II August 31, 2026



International Consulting Engineers (ICE)

- Engineering firm
- Grant: \$125,000 approved by City Council May 2018
- Grant paid: \$100,000
- Grant remaining: \$0
- Expired: 05/12/23
- The construction is complete \$1,422,850





Texas A&M University – CC Industrial and Civil Engineering

- Build out laboratory spaces for two new engineering curricula
- Grant: \$2,000,000
- Grant paid: \$1,152,097
- Grant remaining: \$847,903
- Expires: 12/31/23
- 141 students in both curricula and 212 in pre-engineering (Fall 22 and Spring 23 total)
- Balance of grant to be expended by Fall of 2023 semester:
 - o Two more pieces of equipment-shear mixer and concrete 3-D printer.
 - Facility modifications for the relocation of existing equipment to create a laboratory space for the concrete mixer and 3-D printer
 - Hardware (computer) and software purchases budgeted as part of the startup package for the new faculty member to create computational lab for instruction in logistics, operations research, and systems simulation.





Texas A&M University – Lone Star UAS Center

- Grant: \$4,000,000
- 2 positions hired
- Mission Control upgrades have been purchased
- Thales installation expected to be complete by May 2023
- Beyond-Visual-LOS Study (\$250,000)
- Second Mission Control (\$2.13 million)
- Supporting Centers (\$1.62 million)
- Grant paid: \$1,205,039
- Grant remaining: \$2,794,961
- Expires: 10/18/28





LiftFund Interest Buy-Down Program

- Micro lender
- Grant: \$100,000 for the fiscal year
- Grant paid: \$81,262
- Grant remaining: \$18,738
- Loans Total: \$270,144
- Expires September 30, 2023





Service Corps of Retired Executives (SCORE)

- Provides counseling and workshop training for small businesses. Most requests are start-up business plans, e-commerce, funding options, and LLC creation. Handled 473 cases. Also held 22 workshops with 427 attendees
- SCORE has 13 certified mentors, seven are self-employed or employed FT, six are retired. SCORE is advertising for additional volunteers on KIII-TV and social media. The ad campaign to advertise mentoring services starts in May 2023.
- Grant: \$70,000 for the fiscal year
- Grant paid: \$ 64,276.31
- Grant remaining: \$5,723.69
- Expires September 30, 2023

- Help small businesses by providing student interns. These interns work in their major area of study, the Type B fund pays an extra \$7.25/hour in addition to the hourly wage paid by the business
- Grant: \$100,000 for the calendar year

- Grant paid: \$62,131
- Grant remaining: \$37,869
- Expires: December 31, 2023

- Expires: December 31, 2023






Del Mar College APEX Accelerator (formerly PTAC)
