Melina made a motion to approve the minutes as presented, seconded by Sara and passed unanimously.

E. Unfinished Business

2. [24-0846](#) FY 24 Arts Grants Update

Staff Liaison, Eleanor Miceli shared that the FY 24 agreements have been sent for signatures. Five agreements have been finalized with organizations receiving their first payments the following week. The Coastal Bend Restaurant Week did not originally qualify as a non-profit. They were given the opportunity to re-apply. Commission members expressed concerns whether re-application should be allowed. The timeline has been violated, and the application is being done through a separate organization.

Commission members agreed to decline the application to prevent future conflicts.

Eleanor shared the process of terminating inactive members. The ACC will be presented at council on August 13, 2024. Staff liaison to confirm dates for filling new positions and term years of current members. In the case that Dr. Abu is on his final term, three positions will need to be filled. An architect is preferable as a new member. Dr. Abu and Sara to look into recommending new members. The Arts Forum is confirmed to be held on October 9, 2024 at the Art Museum of South Texas.

Eleanor shared quotes and suggestions on re-printing the Public Art Collection booklets. Roughly 2,700 copies are left in inventory. Commission members suggested locations to distribute booklets (Hotels, Visit Corpus Christi, etc.). Commission members agreed on a brochure style print instead of a booklet. Possibilities of an app or website were discussed.
