**8. 24-1138 Commodores Park Discussion w/ Possible Action**

\*Suggestion to keep sports tournaments in mind when designing/deciding the size of the pool/courts/etc.

Billish Park - proposal to move proposed skatepark from Commodore to Billish Park. Funding is a big part of the move, potential to use TIRZ #2 to fund, would like to use the West Guth skatepark design to minimize costs, would be around \$500k for full design and construction, can solicit community input but wouldn't be able to change the design a ton to keep costs down, parking would be included, approximately 9,000 sq. ft.

\* Discussion of using Cole Park skate park design instead, but it is a much larger footprint (11,000 sq. ft.) due to the large bowl and would need to pay to update the design to fit Billish Park.

Resolution of support proposed by Cheryl Segrest for the implementation of a skate park at Billish Park to be built as soon as possible. Second by Stephen Armstrong. Passed unanimously.
