#### **Botanical Gardens**

- Grant: \$89,000 approved by City Council in July 21, 2020
- Start construction by September 1, 2020
- Received TPW Recreation Trails grant of \$200,000
- Working to get required reports complete
- May need an extension
- Expires: 08/21/23





#### **Del Mar College Process Technology II**

- Addition to the Process Technology plant
- Grant: \$2,356,000 approved by City Council in August 2018
- Grant paid: \$2,315,396
- Grant remaining: \$40,604
- Is operational, should use all of the grant
- They have 698 enrolled and 284 graduates
- Expires: 08/21/23





#### **New Sports Company**

- Grant of \$1,850,000 was signed on October 23, 2020
- Agreement was amended January 23, 2021 to allow owners more time to complete financing of the project
- Must complete construction by November 30, 2023
- Owner purchased an additional acreage adjacent to the site for parking and cleared land
- Working with Development Services to get permitting to start construction
- Having problems with supply chain, may need an extension.



#### **International Consulting Engineers (ICE)**

- Engineering firm
- Grant: \$125,000 approved by City Council May 2018
- Grant paid: \$75,000
- Grant remaining: \$25,000
- Expires: 05/12/23
- The construction is complete \$1,422,850





#### Texas A&M University – CC Industrial and Civil Engineering

- Build out laboratory spaces for two new engineering curricula
- Grant: \$2,000,000
- Grant paid: \$1,122953
- Grant remaining: \$877,047
- Expires: 12/31/23
- 141 students in both curricula and 212 in pre-engineering (Fall 22 and Sprii
- Balance of grant to be expended by fall 2023 semester:
  - Two more pieces of equipment-shear mixer and concrete 3-D printer.
  - Facility modifications for the relocation of existing equipment to create space for the concrete mixer and 3-D printer
  - Hardware (computer) and software purchases budgeted as part of the start-up package for the new faculty member to create computational lab for instruction in logistics, operations research, and systems simulation.

- Have three in the pipeline to be completed
- Loans total \$0
- Expires September 30, 2023





#### **Service Corps of Retired Executives (SCORE)**

- Provides counseling and workshop training for small businesses. Most requests are start-up business plans, e-commerce, funding options, and LLC creation. Handled 505 cases. Also held 12 workshops with 449 attendees
- SCORE has 13 certified mentors, seven are self-employed or employed FT, six are retired. SCORE is advertising for additional volunteers on KIII-TV and social media. The ad campaign to advertise mentoring services starts in May 2023.
- Grant: \$70,000 for the fiscal year
- Grant paid: \$ 34,470
- Grant remaining: \$35,530
- Expires September 30, 2023

- Expires: December 31, 2023






#### **Del Mar College PTAC Procurement Technical Assistance Center**

## Brief on the CRC local economic impact:

- The Del Mar College Contractor Resource Center (CRC) has had a successful 1st quarter. The CRC has assisted 39 clients, signed up 6 new clients, and held 73 client sessions. CRC clients have reported \$495,800 between 8 contracts with several others waiting to be awarded.
- In July of 2022, the CRC began using Constant Contact® to email a weekly LEADS campaign to their clients. The email consists of a list of local construction projects in the planning, bidding, and post-bid stages obtained from ConstructConnect®, a construction software bid tool the CRC offers as a benefit of becoming a client. The CRC encourages their clients to visit the center to access ConstructConnect® and view the project details of the projects listed on the LEADS list while also offering to send them an electronic version for the client's convenience. In this first quarter, the CRC has successfully increased the open rate of this email to 51 %, has held 18 Construct Connect client sessions, and has sent project details for 30 projects electronically.
- Another perk the CRC offers to its clients is the opportunity to use our plan room to print plans for commercial projects. Every month each client can print 50 pages of plans at no cost followed by \$1 per page thereafter. The CRC provided a total of 642 pages of commercial plans printed between 31 projects for 8 clients in the first quarter.
- The CRC continues to provide training event/seminars on preparing small, local businesses to become better qualified for large commercial projects. The CRC recently teamed up with the Texas Department of Insurance (TDI) and held a 30-hour OSHA Construction training class offered at only \$30 for attendees. The CRC saw a total of 10 participants attend the 5-day training with the majority being employees of CRC clients.
- The CRC also continues to work with the procurement team for the Gulf Coast Growth Ventures (GCGV) an Exxon Mobil and SABIC Venture following the procurement event in September of 2022. Out of the 110 attendees, 30 companies have successfully registered as vendors. The CRC plans to maintain its relationship with GCGV by working through its Contractor Qualification Process in an effort to help prepare and connect small, local businesses with industry projects.
- The CRC is excited to share that several CRC clients have been awarded a grant from the "Doing Business with Giants" workshops. As you may recall, this event was partnered with Cheniere Energy and the Innovation Center at TAMU-CC as a way to assist local businesses by providing grants upon completion of attending all six workshops. CRC is currently capturing the number of recipients that are CRC clients and the amounts awarded.
- CRC upcoming training events includes a bonding series, quality management systems and health and safety. We recently learned that CRC bus bench advertisement that was purchased for 2022 is still out in the community and offered to us at no cost. We continue to market the program by collaborating with internal relationships as well as with our stakeholders.
