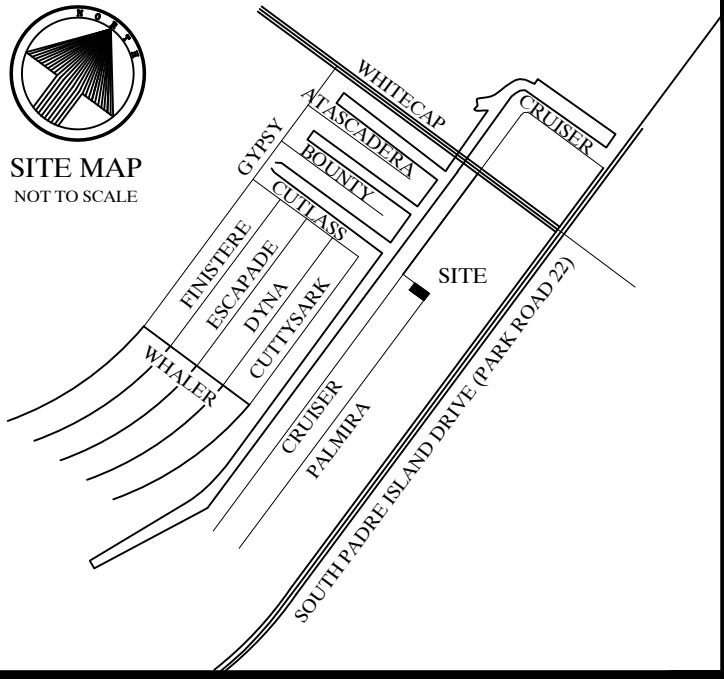




SITE MAP

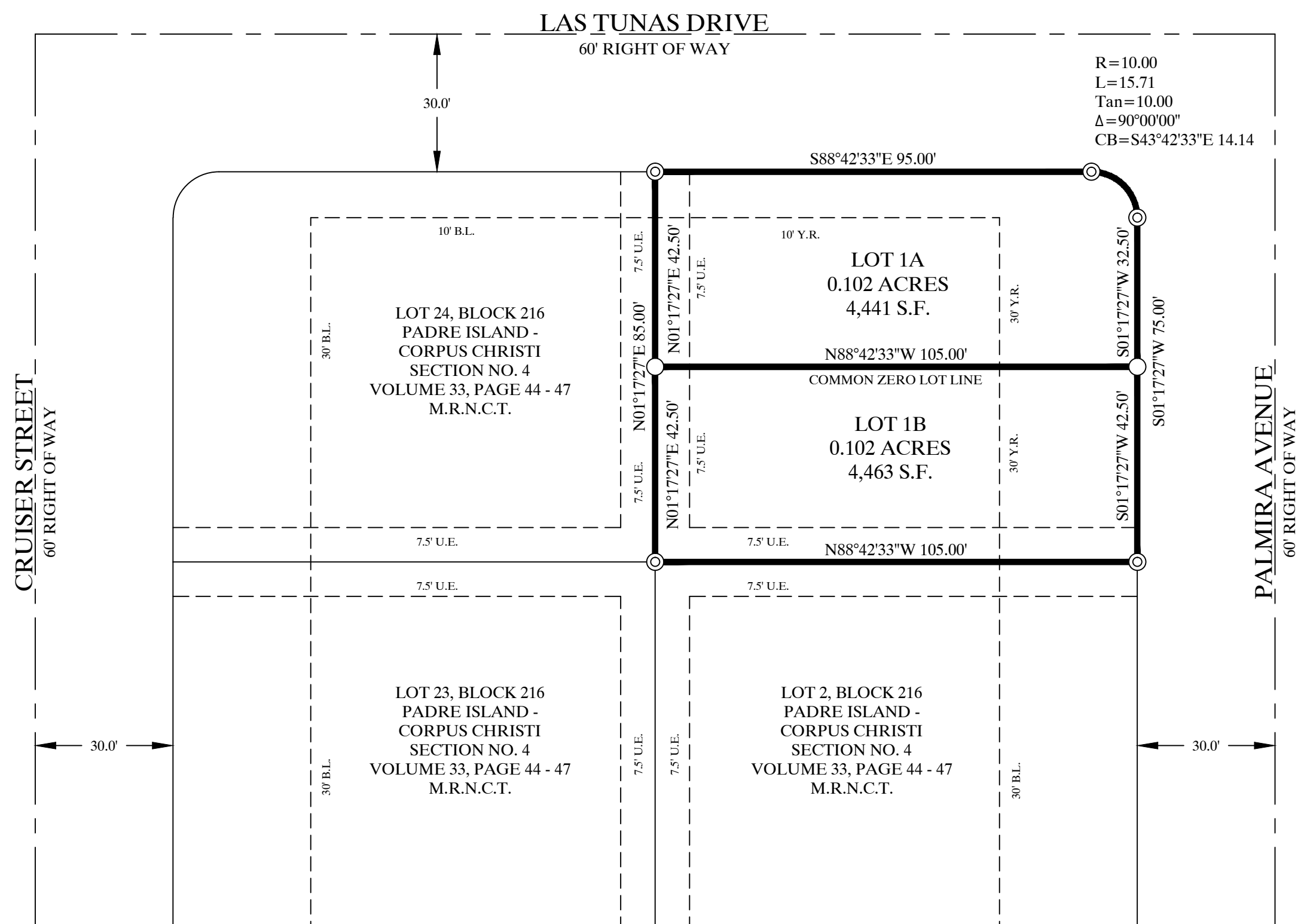
