Ordinance to adopt the fiscal year (FY) 2014-2015 Consolidated Annual Action Plan (CAAP), for the Community Development Block Grant (CDBG), the Emergency Solutions Grant (ESG), and the HOME Investment Partnerships (HOME) Programs; to authorize the City Manager or designee to submit the FY2014-2015 CAAP to the U.S. Department of Housing and Urban Development (HUD), and to amend if required by HUD; to authorize the City Manager or designee to execute all documents necessary to accept and appropriate upon receipt the grants from HUD into the Grant Fund No. 1059 for the approved FY2014-2015 CAAP projects and further to execute funding agreements and all other documents necessary to implement the FY2014-2015 CAAP with organizations for approved projects.

Whereas, with proper notice to the public and in accordance with HUD regulations, three public hearings were held, the first and second on December 5th and 9th, 2013, and the third during a meeting of the City Council, in the Council Chambers on Tuesday, June 10th, 2014. All hearings were held at City Hall, in the City of Corpus Christi, during which all interested persons were allowed to appear and be heard; and

Whereas, the City Council has determined that this Ordinance would best serve public health, necessity, convenience and the general welfare of the City of Corpus Christi and its citizens.

Now therefore, be it ordained by the City Council of the City of Corpus Christi, Texas:

Section 1. That the FY2014-2015 CAAP, which includes the CDBG, the ESG, and the HOME Programs, is adopted.

Section 2. That the City Manager or the City Manager's designee is authorized:

- to submit the FY2014-2015 CAAP to HUD, and
- to amend the FY2014-2015 CAAP if required by HUD.

Section 3. That the City Manager or the City Manager's designee is authorized:

- to execute all documents necessary to accept and appropriate upon receipt the grants from HUD into the Grant Fund No. 1059 for the approved FY2014-2015 CAAP, and
- to execute funding agreements and all other documents necessary to implement the FY2014-2015 CAAP with organizations for approved projects.
