2. [26-0336](#) Fuel Station Update - John Murray

Mr. Murray advised he needs to meet with City staff again regarding insurance requirements for the fuel station, but he has acquired the fuel tanks and building. He has a meeting set with the fire marshal to review the site plan.

Mr. Dunlap advised he met with the Parks and Recreation grant coordinator, Faye Rencher. She stressed the importance of having funds in place to match a potential grant before applying.

**F. Director's Report**

In the director's report, Marina Manager Jonathan Atwood advised of upcoming events, Buc Days begins at the end of April and the Port A Regatta is April 25th-26th. Marina staff have started going over hurricane plans and updating contact information.

Mr. Atwood advised contractors have a small punch list of items to finish on C and D piers, along with paving the parking lot. Demolition of the Coopers Alley Boaters facility will take place in a week or two, once AEP disconnects power. The haul out and office construction project did not go to council in April and will need to be rescheduled. Mr. Atwood would like the project to begin in early September to avoid having two ongoing construction projects on Coopers Alley during the high season. The Peoples Street Boardwalk opened on March 27th.

**H. New Business for Discussion and Possible Action**

Mr. Broomfield suggested installing shade structures and picnic tables throughout the marina for the benefit of tourists and locals.

Mr. Broomfield insisted the marina is losing out on revenue opportunities with the lack of vendors such as the previous snow cone vendor on Peoples St and charter boats.

9. [26-0509](#) Boat Races in Marina

Mr. Broomfield suggested bringing boat races back to the bayfront, as seen at the international boat show. Mr. Atwood advised he spoke with P1 Power Sports a few years ago and they required \$500,000 from the City to hold another boat race here. Mr. Murray offered to contact a former colleague about the possibility of boat races.
