Dump Truck Hauling Services

CAPTION:

Motion authorizing execution of a one-year service agreement, with two one-year options, with Trout Trucking Company, Inc., in an amount not to exceed \$485,610.00, with a potential up to \$1,456,830.00 if options are exercised, for hauling services and disposal of excavation and construction materials for Corpus Christi Water, with FY 2025 funding of \$121,402.00 from the Water Fund.

SUMMARY:

This motion is authorizing the execution of a one-year service agreement with two additional one-year option periods with Trout Trucking Company, Inc., for hauling services that will be used to move backfill, spoil, and other construction materials.

BACKGROUND AND FINDINGS:

The hauling service agreement is for the transport of various materials used in or resulting from the construction and repair of water and wastewater infrastructure. During construction materials that are removed from excavations (spoil) must be hauled and disposed of at approved facilities around the city. The vendor will haul dirt, concrete, and miscellaneous materials such as brush, sand, gravel, wet dirt, etc. from various locations throughout the city to the Cefe Valenzuela landfill. In addition, materials that are used in the backfill and repair of infrastructure may need to be hauled from various vendors to jobsite locations. These materials include cement stabilized sand, asphalt, cushion sand, gravel and caliche. This contract will augment current staff and provide the resources needed during large construction projects, staffing shortages or when

excessive failures exist.

PROCUREMENT DETAIL:

Finance & Procurement conducted a Request for Bid (RFB) process to obtain bids. The City received one responsive, responsible bid and two no bids. Staff recommend the award to the lowest, responsive, and responsible bidder, Trout Trucking Company, Inc.

There were 160 notifications sent out to registered vendors via the City's Supplier Portal.

ALTERNATIVES:

An alternative to awarding this service agreement is to reject the bids and not enter into an agreement, which would require staff to solicit quotes on an as-needed basis, which could result in a time delay due to the procurement process.

FISCAL IMPACT:

The fiscal impact for Corpus Christi Water for FY25 is \$121,402.00 from the Water Fund.
