2. [26-0336](#) Fuel Station Update - John Murray

Mr. Murray advised a list of requirements for the fuel station tanks had been provided to him and he is going through those to make sure all equipment would comply.

3. [26-0337](#) Grant Update - Don Dunlap

Tabled due to Mr. Dunlap's absence.

Mr. Herrington did not have an update on safety and clean up.

Mr. Stokes did not have a marketing update, but commended the city for the social media posts featuring the marina.

F. Director's Report

Mr. Atwood advised the marina office will be closed on May 25th due to Memorial Day and the Corpus Christi Yacht Club will be hosting the ILCA 2026 US Championship that weekend. The L-head will be busy, not only with construction, but holiday weekend boaters, and nearly 90 sailors registered for the championship. The dunking of the mayor went off without a hitch; Corpus Christi Fire Department assisted her out of the water after she jumped from the pirate ship. Bellingham Marine installed the new docks at the boat ramp with upgraded materials that include composite boards and stainless-steel hardware.

G. Unfinished Business**6. [25-0155](#) Capital Improvement Projects Update**

Mr. Atwood advised the A, B, C, D, & L pier project to be completed the next day on May 5. All docks are open and the dredging is complete. IT will install cameras and locks on May 5, and the contractors are cleaning up their laydown yard with plans to vacate by the end of the week. Demolition of the Coopers Alley Boaters facility is complete, and temporary restrooms have been provided by the contractor. Next week they're installing a test pile, and the estimated completion date is within 9 months. The haul out and office construction project will go to council in June.

Mr. Broomfield reminded the committee that 3 absences per term year are allowed and emphasized the importance of attending meetings.

8. [26-0667](#) Commercial Operators - Water Taxi, Fishing, Tour Boat

Mr. Broomfield stressed the importance of having vendors and things to draw people from Shoreline Blvd down onto the T-head. Mr. Atwood advised someone approached him with the idea of a floating food stand, and that Harrison's Landing is looking to sell the Texas Tease and possibly retire the Japonica tour boat with the intention of purchasing newer tour boats that may double as future water taxis. In addition, Harrisons Landing is looking at adding a floating tiki bar.
