2-Hour Parking Signage





- Downtown businesses affected by parking challenges due to construction
- No parking time limits along the unmetered parts of Chaparral St.
- 2016 Parking Action Plan recommends 2hour time limits Monday-Friday, 8 A.M. – 6 P.M. in high traffic areas to generate turnover.
- DMD board made a motion to implement 2hour parking limit signage along unmetered potion of Chaparral St. at August Board Meeting.



Sidewalk Cafés & Parklets

- DMD strategy to create beautiful streetscapes and interactive public spaces through urban design through implementation of parklets & sidewalk cafes.
- Worked with 3 businesses to submit applications for 2 sidewalk cafes and 1 parklet.
- City provided new comprehensive application for sidewalk cafes & parklets.
- Continuing to work with businesses through the application process.
- Status:
 - Peoples St. Parklet: postponed until street work complete in January
 - The Bridge: making edits to design
 - Old Kress Live: awaiting approval of new application










ADA Accessibility



- DMD team witnessed various instances of people with limited mobility struggling to traverse through downtown due to inaccessibility of sidewalks and streets.
- Conducted audit of downtown streets & sidewalks for ADA accessibility in April.
- 50 instances of streetscape out of compliance.
- Met with residents of Trinity Towers on 6/16 to conduct community engagement.
- City has agreed to allow use of scooter funds to address problem areas.
- DMD submitted report to City with recommendations.

- TIRZ #3 Board Requested Update:
- 3x annual plant changeouts now conducted in-house with Clean Team.
 - Clean Team Manager is Certified Master Gardener
 - Plants are grown specifically for DMD
 - Plants donated at end of season
 - Considering composting options
- 2023 Planter Changeouts
 - April: lantana (native)
 - July: periwinkle (drought tolerant)
 - October: petunias, ipomoea & snap dragons (all drought tolerant)
- Considering native pollinators for future plantings.







Retro Rooftop Patio Grand Opening




Location	326 N. Chaparral Street
