Parks & Recreation Advisory Committee (Jay Gardner)
Looked over Commodores Park Master Plan, encouraged the city to move forward,
Parks looking at waterlines being taken out to Billish, Briscoe King Pavilion discussion,
recommendation to support the ISAC resolution for skatepark on the island, would like to

leave it in the Commodores Plan and then move forward with the Billish resolution, whichever gets us there faster.

Nueces County (Dr. Bryan Gulley)

Big news is Briscoe King Pavilion, \$5.9 million from the TIRZ total for the project, looking to get it started right away 6 months of planning and then 12-14 months to build, wants to reserve for ISAC in the future, pier will be ready soon, Callen Marine is running on time, restaurant a little behind but not far, should be ready to go within a year or less than, had a \$3 million dollar plan to extend the boardwalk, set on large pilings for folks to walk on, money from the GLO, looking at the erosion problem with the living shoreline.

Visit Corpus Christi (Meredith Darden, submitted via email)
Spring Break Forecast & Preparedness – Key Takeaways
Increased Destination Marketing Efforts Align with Shorter Booking Windows

- 1. While occupancy on the books (OTB) is currently pacing behind last year, traveler sentiment data shows more visitors are booking closer to their travel dates, within as little as one week of departure., meaning there is still time to influence last-minute decision-makers.
- 2. Our data suggests March 14-22, 2025, will see the highest visitor activity, with an expected two-part peak around March 14-15 (weekend arrivals) and March 21-22 (extended family vacations and late-season travel). Last-minute bookings will be key to closing midweek occupancy gaps.

Increased Last-Minute Bookings Expected

- 1. While many travelers are booking within as little as one to two weeks of departure, we're starting to see the booking window close to shorter than 1 week with many travelers deciding within a couple of days to determine weather conditions.
- 2. Weekend occupancy (Fridays & Saturdays) remains strong, reinforcing the potential for last-minute drive-market travelers to fill midweek gaps.
- 3. We are utilizing targeted digital campaigns, and real-time deals will help convert undecided travelers into Corpus Christi visitors.

Favorable Weather Strengthens the Value Proposition

- 1. Current forecasts for 78418 indicate mild temperatures and low precipitation risk for early March, reinforcing Corpus Christi as an ideal Spring Break getaway. Destination Readiness Efforts Are in Place
- 1. Visit Corpus Christi's Spring Break Readiness Campaign is reinforcing visitor safety, beach cleanliness, and enhanced visitor information access, ensuring an optimal experience.
- 2. Our partnerships with local businesses, law enforcement, and hospitality partners ensure a seamless experience for both planned and last-minute visitors.

3. **24-0896** Beach Updates

Darren Gurley, Gulf Beach and Natural Resources Superintendent, Parks & Recreation Dept.

Hauled about 21,000 tons of sand from the pile on Zahn to the Seawall, made it through the Barefoot Mardi Gras parade, parade went off without a hitch, had a good turnout,

getting ready for spring break, trash cans and restrooms out, getting ready for the weekend, still moving sand.

4. 24-0897 Parks Updates

Sergio Gonzalez, Assistant Director, Parks & Recreation Dept.

Just a few updates, wanted to thank Darren Gurley, Stan Hulse, and Dan Suckley for all of their hard work for Barefoot Mardi Gras, only issues were the highway barricades that were oversized, fixed pretty quickly, great showing with staff and beach rescue in attendance. Director of Parks Robert Dodd and Sergio went to TRAPS recently to meet with other Parks departments and vendors, actually looking at samples for lighting for trails, lots of great ideas. The conference will be in Corpus Christi next year, expecting around 2,000 visitors, they're already excited to go to the beach (next February), lifeguards (10) on staff all week for Spring Break.

Updates provided by Craig Thompson, Chair of ADP Subcommittee
Had some good meetings, included JJ Hart and Jay Gardner as subject matter experts,
projects assessed from ADP project list as well as TIRZ projects, created one large
spreadsheet, broken down by category for review.

Looking at the financial capabilities of the TIRZ prior to recommending projects. Also working to identify the funding options like CIP, Bond, etc. Mobility Plan is a high priority. Suggestion to look at grants for funding certain projects once the subcommittee has been able to dig into them.

Discussion about Whitecap Effluent Water Reuse, proposal to expand the scope to other areas like Billish Park and other public areas in need of irrigation. The project is fully funded currently, expansion would need additional funding. (was there any funding leftover from this project?) Looking at taking it up through Commodores and Billish as well. Also looking at puling that under PR 22 to bring water to the other side.

7. <u>25-0153</u> FY25 Budget Priorities Discussion

Question about items that are funded and ongoing – should they be under consideration?

Definitely want to get some cost estimates for review, would like to see what funding has been allocated to which projects.

Heather Hurlbert, Assistant City Manager – right now based on the projects we have committed to plus the annual expenses, we don't have a ton of capacity in the TIRZ #2 so we need to prioritize the projects so as we move forward, we know which to move forward with.

Need what was expended on the effluent line to gauge if any money is leftover. Also need more information on the Paper Streets projects (Sand Dollar currently in design).

Discussion of Bond 2026 – have not run the numbers on the potential Bond program, parks the most popular, streets scheduled out but can be included, anything with utilities can be checked against Utility Department CIP/10-year plan (or CCW). There are a lot of projects that are already slotted within their 10-year plan.

Grants – importance of community buy-in, makes the application more competitive, perhaps utilize the Mobility Plan to leverage construction grants?

Remove (slide 9) Whitecap Wastewater Treatment Plant Odor Control & Bulkhead Improvements (complete!)

Question about money from older Bonds that could be used on the island, but bond money must be used within 3 years, not allowed, city tries to spend down the funding in entirety.

TPWD Grant for boat ramps? Priority on list could utilize Packery Channel money already being set aside.

Type B Question – used for commercial and industrial streets, can we use Type B money for Paper Streets? Eligible, also projects for coastal resiliency included.


Marvin Jones – question about the total amount of debt that the city has, we have it on our website under Financial Transparency.

Proposed language drafted with Homebuilders Association support:

For new construction of any residential structure on Padre Island or Mustang Island, rear and side yard slopes may not exceed 10% grade slope from the foundation to the adjacent property except where a sealed drawing and plan have been submitted by a professional engineer licensed in the State of Texas verifying that stormwater runoff from said yard will not drain to adjacent neighboring properties. Such sealed drawings and plans must be submitted to the floodplain administrator for approval.

• ISAC Subcommittee Proposed Language following the meeting with the Homebuilders:

Builders for all new construction of any residential structure on Padre Island or Mustang Island are prohibited from constructing exterior drainage that will flood, impound water, or damage adjoining property. The side yard slope shall not exceed 10% grade slope from the foundation of the new construction to the adjacent property level. However, this requirement may be waived by the City of Corpus Christi in certain circumstances, such as corner lots, and where the engineered and stamped plans provide adequate alternatives, as described below. In addition, each new construction of any residential structure shall have a Texas state-licensed engineer design and seal plans for the above-required drainage. The plans shall be submitted to the City of Corpus Christi, including development services and the floodplain administrator, for approval. Each plan must specify the construction techniques to be used by the builder to facilitate compliance with this ordinance.

Updated Proposed Language

For all new construction of any residential structure on Padre Island or Mustang Island, the following apply:

- (1) Builders for all new construction of any residential structure are prohibited from constructing exterior drainage that diverts water in a manner that damages neighboring property.
- (2) The rear and side yard slope shall not exceed 10% grade slope from the foundation of the new construction to the adjacent property level, except:
 - (a) for residential structures on corner lots; or
- (b) where a sealed drawing and plan have been submitted by a professional engineer licensed in the State of Texas, verifying that stormwater runoff from said yard will not damage neighboring property. Such sealed drawings and plans must be submitted to the floodplain administrator. Each plan must specify the construction techniques to be used by the builder to facilitate compliance with this ordinance.

Staff & Legal Comments

- During the meeting with the ISAC subcommittee and the Builder's Association, there was a consensus for an exception, not a waiver, for licensed engineered plans. A waiver implies discretion where an exception is required.
- The term "will flood" may be too broad as flooding is allowed where a drainage easement exists.
- The term "adjoining" is too specific; "neighboring" is a better term.


