* Rocks are being put in at Packery Channel, also building a small pier on the other end, park is currently closed for construction, looking at drilling a well.

3. **24-0896** Beach Updates provided by Darren Gurley, Gulf Beaches and Natural Resources Superintendent, Parks & Recreation Department

Spring Break went well, no major issues, Access Road 2 was a little congested but everything went smooth, Easter was rained out and flooded the beach, looking to start hauling sand next week in front of the seawall, will keep building it up out front of the hotel and will try to build out as far as possible and move the bollards with it.

4. **24-0897** Parks Updates provided by Sergio Gonzalez, Assistant Director, Parks and Recreation Department

Commodores Park is moving along, the slab for the basketball court has been poured and columns are going in. Lighting has been improved for pickleball and tennis courts as well as the trail (which will now have bollard lighting instead of AEP). Engineering is currently awaiting the 60% design submittal for the Billish Park Skatepark.

Commodores Park MP Phasing:

- Phase 1A (\$5M) - covered basketball court, two tennis courts, four pickleball courts, bird observation deck, picnic tables, concrete walking trails, park lighting, and parking lot.

- Phase 1B (\$5M) - 6,500 sq. ft. community swimming pool, 3,500 sq. ft. air conditioned bath house, pump room, perimeter fencing, and minimal landscaping.

- Phase 2 (\$3.8M) - 8,000 sq. ft. air conditioned gym
