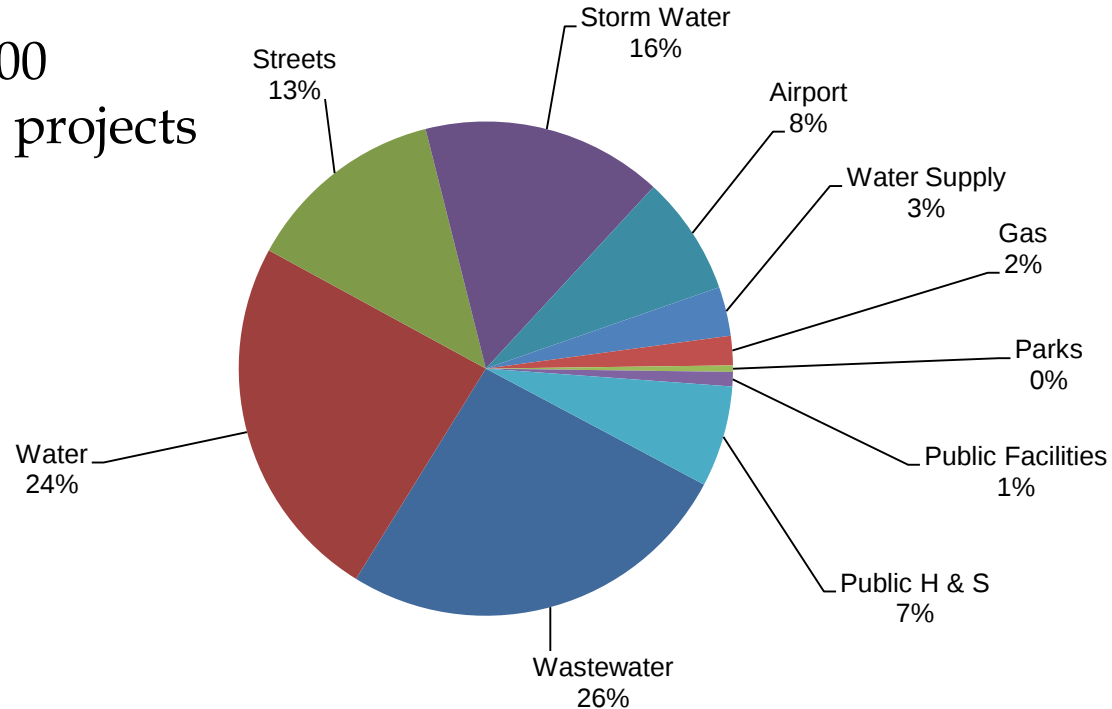

- \$212,551,300
- 160 Active projects





Airport

- Year One: \$16,565,500
- *Program Highlights:*
 - Air Operations Area Perimeter Fence Replacement
 - Taxiway Reconfiguration
 - Rehabilitate East General Aviation Apron
- *Funding Sources:*
 - Federal Aviation Administration Grants
 - Customer Facility Charges
 - Airport Fund Reserves



Parks & Recreation

- Year One: \$894,500
- *Program Highlights:*
 - Completion of previously funded Bond 2012 projects
 - Ben Garza Park Improvements
 - Sacky Park Improvements
 - Packery Channel Miscellaneous Improvements
- *Funding Sources:*
 - General Obligation Bonds (2012)
 - Community Development Block Grant Funds



Public Facilities

- Year One: \$2,000,000
- *Program Highlights:*
 - Comprehensive Facilities Improvements
 - Completion of previously funded Bond 2012 projects
- *Funding Sources:*
 - Certificates of Obligation
 - General Obligation Bonds (2012)



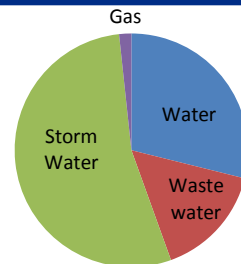
Public Health / Safety

- **Year One: \$14,260,300**
- ***Program Highlights:***
 - Cefé Valenzuela Landfill disposal Cells Interim Cover – 3D, 4A & 4B
 - Cefé Valenzuela and JC Elliott Landfills Leachate Management
 - Cefé Valenzuela Landfill Gas Collection and Control System
 - Seawall Maintenance
- ***Funding Sources:***
 - Certificates of Obligation
 - Sales Tax Funding (Type A Board)



Streets

- Year One: \$27,894,700
- (Utility Support: \$47,425,400)



Gas: 800,000
WW: 7,404,500
Water: 13,696,300
SW: 25,524,600

- *Program Highlights:*
 - Yorktown Boulevard – Everhart Road to South Staples
 - Rodd Field Road Expansion
 - Gollihar Road – South Staples to Kostoryz (3 Phases)
- *Funding Sources:*
 - General Obligation Bonds (2012)
 - Texas Department of Transportation Funding
 - Utility Revenue Bonds



Gas

- Year One: \$4,079,800
- *Program Highlights:*
 - Gas Line Replacement / Extension Program
 - High Pressure Cathodic Protection Master Plan
 - West Side Interior Loop
- *Funding Sources:*
 - Gas Revenue Bonds
 - Gas Department Reserves (*Pay as you go*)



Storm Water

- Year One: \$33,524,600
 - *Program Highlights:*
 - Lifecycle Pipe Rehabilitation and Replacement
 - Major Outfall Assessment
 - Lifecycle Curb and Gutter Replacement
 - *Funding Sources:*
 - Storm Water Revenue Bonds
 - Storm Water Department Reserves

Water Supply

- **Year One: \$6,811,700**
- ***Program Highlights:***
 - City of Corpus Christi Reservoir Operating System Infrastructure Improvements
 - City of Corpus Christi Aquifer Storage and Recovery (ASR) Feasibility Study
 - Wesley Seale Instrumentation Testing and Replacement
- ***Funding Sources:***
 - Raw Water Supply Reserves
 - Water Revenue Bonds



Water

- Year One: \$51,252,700
- *Program Highlights:*
 - Elevated Water Storage Tanks
 - Programmed Waterline Service Life Extension
 - Oso South Area Water Line
 - Support of Street Bond Projects
- *Funding Sources:*
 - Water Revenue Bonds
 - Water Department Reserves



Wastewater

- **Year One: \$55,267,500**
- ***Program Highlights:***
 - City-wide Collection System Assessment and Repair (SSOI)
 - McBride Force Main and Lift Station
 - Oso South Area Wastewater Line
 - Support of Street Bond Projects
- ***Funding Sources:***
 - Wastewater Revenue Bonds
 - Wastewater Department Reserves
