- Barefoot Mardi Gras was packed; beach maintenance did a great job. Spring Break is coming in the next few weeks, 14 guards in mobile units will be on the beach, no lifeguard stands until Memorial Day weekend. No splash pads this spring break due to drought. Collier Pool and the Natatorium will be running under their normal hours. Bill Witt restrooms currently in repair.

- Billish Park – waiting on signatures from Engineering Services, should be complete by EOW.

- Holly Trestle Trail is at 90% design, meeting later this week to discuss with Engineering Services.
