- Pat Shackelford spoke in support of having a wide variety of material and stated that parents should guide their children.
- Salem Martinez spoke in support of having LGBTQ material and expressed concerns about censoring.
- Robert Kymes spoke in favor of the library providing LGBTQ material, important to have LGBTQ books available because some might identify with the characters and find support through books. Library for all people.
- Carolina Avsar expressed concerns about banning books that display diversity.
- Robert Wooster supports the statement in Collection Development policy "patrons are free to choose what they want from the collection, and to reject what they don't like, but not to restrict the freedom of others to choose." Attempts to censor books historically fail and lead to unintended consequences.
- Victoria Holland supports the Board and having a diverse library collection, and feels that there is miscommunication about the board. It's not about banning it's about the procurement process.
- Teresa Klein spoke on the importance of having resources available on sex education

to combat misinformation found on internet and social media sites. Do not restrict options for LGBTQ community, expand them.

- Dorothy Dundas expressed concerns about deciding what shelf books go on, its not about banning, wants appropriateness to be considered, and feels that parental rights are important.
- Alex Flucke, spoke in support of keeping LGBTQ+ books in the library, stated its irresponsible to censor books that do not align with a certain viewpoint. LGBTQ+ community deserves to learn in an environment that supports them.
- Debie Layton, spoke in support of the library system and its staff.
- Matthew Wood, purchased the books that received reconsideration requests, supports having LGBTQ books in the collection and after reading the books feels they are age appropriate.
- Tom Tagliabue, spoke against banning, supports LGBTQ books in the collection and encouraged the board to let people read what they want.
- Roseanne Norman stated grew up reading joke books and Nancy Drew, now you see books with naked men, stated that there are over 400 sexually explicit books in the children's area, which is grooming.
- Alexander Taliaferro, expressed concerns about the unprecedented assault on education in schools, libraries, etc. Once censoring starts it doesn't stop. LGBTQ community needs support.
- Jesus Wong, supports keeping books, libraries provide safe space.
- Peggy Duran supports library staff; parents should decide what their children should read. Have a great library system that is underfunded.
- Jazmeyne Evans expressed concern over book challenges and book bans. The books discussed today have great value, health education should be provided to all ages.
- Becky Moeller wants to see agenda items for better funding, not just moving books.
- Kathleen Naderer submitted a written public comment expressing concern over book challenges and book bans, her comments are attached.
- Julie Rogers, item #4, forming subcommittee. The collection development policy is available on the library website, appeal process is clear and available. If a subcommittee is formed, it should be balanced and fair.
- Vickie Natale, agenda item 5, spoke against removing the book "Doing It Right: Making Smart, Safe and Satisfying Choices About Sex".
