2. **22-0397** Ex-Officio Member Updates: Parks & Recreation Advisory Committee, Nueces County, and Visit Corpus Christi

Parks & Recreation Advisory Committee (Craig Thompson for Jay Gardner)

Nothing specific to the island but Mr. Gardner has been chosen to lead the PRAC subcommittee on trails.

Visit Corpus Christi (Brook Kaufman)

Visitors Center downtown has been closed due to lack of foot traffic, interested in a location on the island, numbers across the board are pretty soft right now including state and national tourism, booking windows have shortened considerably, VCC putting together a market assessment for sports facilities including a committee.

Nueces County (Bryan Gulley)

Pier is on scheduled, not sure about the timeline for the restaurant, initial person who was going to handle the building has backed out.

3. **24-0896** Beach Updates provided by Darren Gurley, Gulf Beaches and Natural Resources Superintendent, Parks & Recreation Department

Made it through the season without anything forming in the gulf, good summer, permit sales increased, doing a lot of work on the seawall, working on repairs and fixing stairs in front of the Wyndham, looking at other minor repairs to complete, hoping to have some sand to move this month but will need to monitor the weather.

4. **24-0897** Parks Updates provided by Sergio Gonzalez, Assistant Director, Parks and Recreation Department

Commodores Park construction contract headed to council on 10/21, Billish Park is moving forward on the permits for the water wells, pickleball and tennis courts in phase 2.

Bryan Carter, Engineering Services Department

- \$7.2M original budget (TIRZ #2)
- Elevation of Verdemar around 9 ft., there are multiple areas where stormwater can go, TxDOT does not want any increases to any water flow into their right of way (connecting to 361)
- Looking at drainage easements parallel to the roadway, will have to work with property owners.\
- Passed 60% design, expect 90% this year, hoping to start early spring 2026 contingent upon a solution to the drainage easement issues.
- Potential bond project for construction
