Update on Commodores Park design, question about the percentages are they for all of the phases or just one at a time, discussed the skatepark (Billish or Commodores), discussed Adopt-a-Park Program that has been added to the Parks website, no information on Adopt-a-Median yet.

Nueces County - Bryan Gulley

Pier is on schedule to be complete in December, small problems with the pilings getting held up, should be able to catch up, the parking lot is the ongoing issue, lots of different requirements from the city, GLO, etc. Going to start the living shoreline soon in Packery Channel Park, also building a lake and extending the boardwalk, lots of projects going on.
