

Plat Requirements

- UDC 3.30.1.A: requires installation of improvements, or financial guarantee, during platting
- UDC 8.1.4: During platting, the “developer shall provide”:
 - A. “Streets, including but not limited to pavement, curb and gutter, ***sidewalks***”
- UDC 8.2.2.A.4: “Sidewalks shall connect to existing adjacent sidewalks or be designed and placed to allow connection to future adjacent sidewalks”



Plat Requirements (cont'd)

- UDC 8.2.2.A.1.a.ii: Within industrial subdivisions, sidewalks shall be required only on streets that meet any of the following conditions:
 - “Through-streets that either are connecting to existing streets or to proposed arterials and collectors.”



Factors

Factors in Support of Waiver

- No current sidewalk exists along Saturn Rd on either side, within the entire Nottarb Place Unit 2 original plat (platted 1972)
- Majority of other properties in subdivision have paved parking lot and drive aisle up to street pavement
- Not on the ADA Master Plan
- No transit stops on Saturn Rd

Factors Against Waiver

- Saturn Rd is in an industrial subdivision and is a through-street connecting an arterial (Weber Rd) to a collector (Kram St)
- Saturn has 60' right-of-way
- Industrial subdivision, employment node, less than 0.25 mi from transit stops, other businesses, a church, and a post office
- Corner lot, and Weber Rd has existing sidewalk to connect to
- Plan CC: Vision for Transportation and Mobility: "connected networks of good streets and sidewalks, safe bicycle routes"



Plat Waiver UDC 3.8.3.D

- **Need for waiver shall be demonstrated to Planning Commission's satisfaction**
 - **The waiver may be approved, approved with conditions or denied after consideration of the following factors:**
 1. Not detrimental to public health, safety, or general welfare, or be injurious to other property in area, or to the City;
 2. The conditions that create the need for the waiver shall not generally apply to other property in the vicinity;
 3. Application of the provision will render subdivision of land unfeasible; or
 4. The granting of the waiver would not substantially conflict with the Comp Plan and the purposes of the UDC

Staff Recommendation

Staff recommends denial of the request for waiver from the sidewalk construction requirement along Saturn Road
