If a member misses a meeting, then they need to attend the next meeting and request an excusal during the agenda item for absence excusals. If the member is not present at the next meeting to request an excusal, then the absence remains "unexcused." Excuses are approved at the following meeting and not at the same meeting from which the member is absent. RSVPs are not considered a formal request for excusal. Mrs. Yankee reminded the Committee that members are allowed two unexcused absences each year of service. Upon the third unexcused absence, the City Secretary's Office automatically deems your position vacated. Excused absences are not counted towards their attendance, therefore, the committee should not excuse absences except for good cause. Chairperson Trevnio asked and Mrs. Yankee confirmed that if a member missed more than one meeting in a row, then they can only ask for an excusal for the last meeting missed.
