6. [25-0155](#) Capital Improvement Projects Update

Mr. Atwood advised A & B piers are 90% completed. AEP has the transformer ready to install, water was tied in last week and sewage will be tied in on August 5th. Work on L pier is lagging due to mistakes made on the fixed section of the pier. Callan Marine has begun dredging behind C & D piers. SR Trident has driven all but 1 pile and has started putting on pile caps for the main span of the Boardwalk. The Coopers Alley haul out facility proposal is being finalized before going out for bid by the end of the year. The Coopers boater's facility is out for construction bids, including the demolition of the lift station.

H. New Business for Discussion and Possible Action

Discussion was tabled to be included with Mr. Herrington's committee report.

8. [25-1222](#) Shoal Outside Marina Gap

Mr. Atwood advised the shoaling outside the gap is not the City's responsibility, but the State is unlikely to take care of it. Mr. Atwood told the committee the shoal shifts with the weather and ship channel traffic, but it is possible to go through the middle where it is deepest. The shoal may be included in a future Peoples Street dredging project.
