2. [26-0289](#) Update on Subcommittees

Commissioner Mumme stated Channel 3 is willing to make announcement regarding the submissions of the upcoming art projects for national preservation month.

Discussion on where to find the correct link on the City's website in order for the public to make submissions or specific designation person where submissions will be made to.

Press release timeframe looks to be at the end of March. This ensures enough time for judging to happen along with the ordering of awards.

Submissions can be anything of historical significance and winners will be announced at the May landmark commission meeting.

Recruitment of judges is on the table so if the commission has any ideas they need to be submitted for determination. Thoughts of a librarian or a history professor

There is discussion to where the submissions for the art projects will be displayed. Suggestions are the Art Center, La Retama, and City Hall. Thoughts of whether all submissions will be on display or only the winners.

Discussion was made about requesting a proclamation for Historic Preservation Month. Last year, they were unable to have one due to it not being submitted in a timely manner.

Commissioner Becquet made a motion to seek a proclamation from City Council for Historic Preservation Month. Commissioner Riggle seconded. The Vote: All Aye. Motion passes.

Walking tour could include the Ritz since they are doing a wall restoration. Commission Becquet stated there is a 10ft wide floor to ceiling project going. This will have the original colors so it would be nice to see what the Ritz looked like in the past. The tour could be for the commissioners, and a video can be taken for public posting.

Old Bayview Cemetery would be part of the walking tour as well. Dr Pruitt stated he would get with personal there to possibly set up a time frame.

Idea of the walking tour to include the Saxet Survey area came from Vice Chair Landreth.

He also stated he would look at last year's press release to see if it can be modified for this year's use. Any correspondence will be sent to Jessica so she can email out to all the other commissioners.
