Commission members were not aware of Visit Corpus Christi's involvement in the review process. Concerns were expressed on Visit Corpus Christi's involvement and their delays. A request was made for better communication. There is no set date for the FY24 arts grant payments to be made. Commission members request a timely arts grant process, as organizations are waiting for payments.
