A. Call To Order/Roll Call

Chair Lindsey called the meeting to order and a quorum was established with Mike Lehnert absent.

B. Public Comment: None.

1. <u>23-1910</u> Regular Meeting Minutes of November 8, 2023

2. 23-1383 Parks & Recreation Department Updates - January 2024

Robert Dodd, Director of Parks and Recreation, gave the following updates:

Mr. Dodd also gave a brief presentation regarding the programs that are offered (Art Classes, Fitness Classes & Holiday/Special Events) at the City's Senior Centers and gave attendance records.

F. Unfinished Business for Discussion or Possible Action

3. <u>23-1793</u> PRAC Bylaw Amendments Regarding Absences

Item "3" was presented at the November 8, 2023 PRAC meeting to consider an amendment to PRAC

Bylaws, Article 4, Section 6. The intent of the amendment is to amendment is to be consistent with Council Policy, Article II Section, 10.2.8. General Provisions for City-Created Boards/Ad Hoc Committees/Task Forces. The Committee held further discussions and it was suggested to amend subsection (b) by replacing the first sentence, "Good cause in the event of an emergency or illness of the Member or family member of the Member." to be read as follows:

"(b) Good cause shall be determined by the Chairperson. The member shall notify the staff liaison and Committee Chair at least 2 hours prior to the start of the meeting, or as soon as practical."

A motion was made by Shawn Flanagan to approve the bylaw amendment as shown above and it was seconded by Adam Rios. The motion passed.

4. 23-1794 Proposed Whitecap Seawall (North Padre Island) Photo Op Sign on Park Land

Item "4" was presented at the last PRAC meeting on November 8, 2023 for PRAC's consideration/support. The Committee brought up several more questions they would like addressed before taking action on a motion of support. The proposed location for the sign is on City property but the Committee wanted clarification if the property is indeed park land.

5. 23-1974 2023 PRAC Annual Report

The Committee reviewed the draft of the annual report which is submitted by the Chair of the Committee. The deadline for the annual report for Boards, Committees and Commissions is January 31, 2024. The Committee made some recommendations to add to the draft and it will be brought back for final Committee approval at the January 10, 2024 PRAC meeting.

H. Subcommittee & Committee Liaison Reports

Island Strategic Action Committee: Twila Stevens gave updates on dredging, Resolution for increase in rate of pay for lifeguards, Mike Ellis parking lot, bathrooms at Zahn Road and an ADA floating access at Packery Channel. These updates were from the November meeting as this Committee will not meet in December.

Water Shore & Beach Advisory Committee: Howard Schauer gave updates on the new Chairperson, goal setting for 2024 and discussions regarding elements/conditions for which lifeguards will enter the water for rescue.

Adopt-A-Park: Chair Lindsey gave updates on the recent tree planting event, becoming a

"Tree City", inventory list of parks not adopted and the possibility of PRAC adopting a park.

Trestle Project

Project Description:

This is a multi-departmental project to construct a 15-foot-wide shared-use path and a new pedestrian bridge across Oso Bay. The project will renovate the existing train trestle bridge and connect the Holly Road and Flour Bluff

Federal Funding Amount for Construction Phase: \$13,034,457

Funding Breakdown:

There is no direct match requirement from the City.



Bird City

Background:

- 2019 2020: An application was submitted to be a part of the Bird City Texas program hosted by Texas Parks & Wildlife Department/Audubon Texas.
- The application was not accepted The Award Committee felt the City did not have enough commitment to fulfill the requirements at the time.
- Per the Texas Wildlife Department website, the program is currently on hiatus & will resume some time this year (no specific date) for new applications.
- Some Committee members may be willing to restart the process, but it will require staff time as well as policy and procedure changes across several City Departments.

Type of Agreement: Use Agreement

No action is required from PRAC at this time since the land is not technically "park land" but staff wanted to ensure that answers were provided to questions from the previous meeting.

Location: Southeast corner of the parking lot at Windward Drive on the seawall. This piece of City property is not technically park land, but PARD maintains it.

• PIBA will maintain, at its own expense, the Premises & all improvements, including the sign(s), landscaping & lighting.

Sherrill Veteran's Memorial Park

- Final survey & boundaries for the helicopter pedestal design are expected in the coming weeks.
- Next steps: Meet with Turner-Ramirez for scope of park-wide design & obtain design cost estimate.

Dog Park at Parker Park

Amenities include:

- Concrete Park Benches
- Dog Waste Stations
- Mock Fire Hydrants
- Large Boulders
- Decomposed granite terrain

Additional amenities as needed to be purchased & installed by Park Ops based off funding availability after construction completion.

Bill Witt Aquatic Center

- Parking Lot 90% poured,
- Main drain, rough-in on the Leisure Pool is complete Pending 3rd party inspection.
- Leisure pool structural steel & floor installation will be inspected by a 3rd party inspection teal
- Electrical/Plumbing Rough-in to the pumphouse has begun.
