2. [25-0634](#) Fuel Station Report - John Murray

The fuel station lease was set to go before City Council on December 9th, but Mr. Dice advised it has been pushed to December 16th because the City Manager still has some questions.

3. [25-0811](#) Grant Update - Don Dunlap

Mr. Dunlap met with the new grant coordinator for the Parks and Recreation department and was very impressed with her knowledge. She already had her eye on a few grants that could pertain to the marina and Mr. Dunlap put another on her radar.

The Illuminated Boat Parade is this Saturday and currently 12 boats are signed up, but participants will be allowed to register as late as the day of the parade.

7. [25-0155](#) Capital Improvement Projects Update

Mr. Atwood advised Callan Marine has almost completed L pier, they're waiting on AEP to connect to the main line. The fire marshal has yet to sign off on the fire suppression system. The Coopers Alley boater's facility construction contract will go before City Council in January. The haul out and office are still waiting on permit documents before going out for bid. SR Trident has placed 2/3 of the panels for the main section of the Peoples Street Boardwalk. The water line will be installed the week of December 8th.

Mr. Atwood advised the Engineering department hired HDR to conduct the breakwater feasibility study. After a survey and report have been completed the report will be reviewed to come up with an alternative options report.
