March Activity Reported at April Meeting	ENG	Discussed the possibility of getting more information on the 311 reports. We also discussed looking into what other cities are doing to potentially refocus our subcommittee to meet the needs better based on what we can get regarding engineering and possibly reaching out to committees in other cities as a search of the internet didn't yield much information. We also discussed possibly trying to find out the views of some citizens from a reporting perspective from report through finish of the process.
	PSA	All subcommittee members accounted for. PSA Subcommittees reviewed the updated brochures and will provide recommendations for any necessary revisions in next PSA Subcommittee meeting, including the potential new addition of relevant local agencies. The subcommittees agreed on using the recommended resolution and are referring it back to the Committee of Persons with Disabilities for final approval. April Activity Reported at May Meeting	ENG	The engineering subcommittee met via text and zoom and discussed that we feel it is the best interest of the subcommittee to focus on a different area than engineering due to the lack of availability to obtain any information on the 311 reports. Several areas of focus were discussed and ultimately we would like to focus on Employment for individuals with disabilities. We discussed several different options within employment and would like to focus on bringing awareness of employing individuals with disabilities.
	PSA	Reviewing and refining the updated brochure is in progress. The discussion will continue in the next PSA meeting, with the meeting date to be determined. The subcommittee will continue to review and provide necessary revisions for the brochure. Discussion points included stock photos with wheelchairs, a broader approach to representation, the addition of NAMI and two of the same phone numbers for both Workforce Solutions Coastal Bend and Texas Workforce Solutions Vocational Rehabilitation Services. We also discussed mental health resources, invisible disabilities rather than just visible disabilities, and decided to remove the City of Corpus Christi - Solid Waste and other departments, as they do not fall under Disability Resources. We will reconvene in the next PSA meeting.
