## Resolution of the City Council of the City of Corpus Christi, Texas in support of the proposed affordable housing project known as Woodland Creek Apartments to be developed by TG 110, Inc.

Whereas, TG 110, Inc. has proposed a development project to demolish and reconstruct 94 apartments to provide affordable housing to be located at 11641 Leopard Street, Corpus Christi, Texas 78410 and named Woodland Creek Apartments ("Woodland Creek Apartment Project"); and

Whereas, TG 110, Inc. intends to submit an application to the Texas Department of Housing and Community Affairs ("TDHCA") for 2013 Housing Tax Credits for the Woodland Creek Apartment Project; and

Whereas, TG 110, Inc. has applied for HOME funding for the Woodland Creek Apartment Project in the amount of \$470,000 from the City of Corpus Christi which represents \$5,000 in funding per affordable rental unit; and

Whereas, Section 11.9(d)(3)(B) of the 2013 State of Texas Qualified Allocation Plan states that one point may be added in the Housing Tax Credits evaluation process if the applicant provides a firm commitment of funds in the form of a resolution from the unit of general local government in its application; and

Whereas, the City of Corpus Christi intends to set aside HOME Funds in the City of Corpus Christi FY 2013 Consolidated Annual Action Plan ("CAAP") to support the TG 110, Inc. Woodland Creek Apartment Project subject to an award of Low Income Housing Tax Credits from the Texas Department of Housing and Community Affairs to TG 110, Inc., and subject to receipt of sufficient available Department of Housing and Urban Development funding.
