#### A. Call To Order

Pat Craig called the meeting to order at 10:30 am.

#### B. Roll Call

Present: Pat Craig, Carrie Moore, Jennifer Anderson, Joan Carrillo, Melinda De Los Santos, Alice Hawkins, Carroll Mathews, Dolores Rabon, Dora Wilburn

Present Virtually: None

#### C. Public Comment

- Becky Moeller said the meeting between the City Manager and board members should have been public, and that the board should have talked about the budget before the policy.
- Guillermo Gallegos said there is no pornography in the library and felt the library budget should be spent on literacy.
- Shawn Flanagan said the new Collection Development Policy and restricted library cards are a tolerant compromise.
- Daniel Resley said there are many opinions on morality and immorality, and he approves of the new Collection Development Policy.
- Aimee Pfeiffer said she works with at-risk youth and that absent parents lead to risky behavior, not books. She stated librarians are not babysitters, and parents should spend more time parenting.
- Cameron Rhodes stated the Citizens Defending Freedom met with the City Manager to push their agenda to remove anything that does not align with their political views such as LGBT material. He said parents should monitor what their children read.
- Kennah Leal thinks that librarians are more qualified than board members and that vague language in the Collection Development Policy is dangerous.
- Tom Tagliabue stated he dislikes the new Collection Development Policy, criticizing its

development process and the City Manager's meeting with board members, and called for more transparency.

- Christina English stated that the library should be for everybody. She was also critical of Citizens Defending Freedom and said they are fascist, citing their website as evidence.
- Eli McKay thinks that moral panic has been manufactured based on a fascist agenda that preys upon people with faith. She said that those who ban books are never on the right side of history, and we should stand against fascism.
- Isabel Arriaza stated that Citizens Defending Freedom and Moms for Liberty are similar to hate groups from history.
- Catherine Barnes thanked staff for creating the Collection Development Policy and stated she likes the new changes and the new library cards.
- Samuel Fryer corrected a previous comment quoted from the Citizens Defending Freedom website. He felt that morality quoted on the website comes from The Bible and we should not be corrupting children.
- Ken Weston supports proposed changes to CDP to move sexually explicit material (new and existing) from children and teen sections to the adult section. He felt that this is consistent with other standards such as not selling tobacco to minors. He then quoted a study that showed negative effects of pornography on minors.
- Francette Maney supports the new Collection Development Policy, she thinks it is not censorship, it is protecting children.
- Katy O'Callaghan thanked staff for creating the new Collection Development Policy. She thinks the proposed changes are helpful. She hopes that staff finds books that inspire a love of literature for youth in Corpus Christi while moving books to new sections.
- Roseanne Norman stated that once a child sees explicit material, they cannot unsee it. She said that parenting all the time is difficult and thanked the board for their efforts.
- Alberto Carrillo thanked the board members for the work they do. He was upset after looking through children and young adult sections and wanted to burn books he found.
- Barb Craig-Schniepp pointed out some inconsistencies in the new Collection Development Policy and asked about provisions for emancipated minors. She also does not like that the new policy removes the phrase "freedom to read is essential to our democracy". Laura Garcia made a point of fact that there are provisions for emancipated minors.
- Rachel Cabellero thinks that both sides need to be careful about what they accuse the others side of. She stated that we should join the fight against local child trafficking.
- Julie Rogers spoke after item 6, Director's Report. She does not think the library should spend money on new library cards and thinks there should be a town hall meeting on the matter.
- Marilena Garza spoke after item 6, Director's Report. She said the board does not listen to public comment or care about the budget and thinks that broad language in the Collection Development Policy can lead to discrimination.

I am writing to submit a public comment regarding the proposed Corpus Christi Public Library Collection Development Policy (CDP).

As a concerned member of the community, I urge the Library Board to delay the decision on this policy until all voices have been heard. The entire community—not just select groups—deserves the opportunity to provide input, including all Library Advisory Board members. A town hall meeting would allow for a more inclusive discussion, ensuring that the policy reflects the needs and values of all Corpus Christi residents.

Additionally, I want to emphasize that there is no pornography in our public libraries. This false claim continues to be used as a justification for unnecessary policy changes, despite the fact that pornography is illegal in public spaces—including libraries. Our library professionals have already developed a CDP based on their expertise and community feedback. I trust our librarians to make informed decisions, and I see no reason to amend or continue debating the Staff-proposed 2025 CDP.

Furthermore, discussions regarding the CDP should not take place behind closed doors. Transparency and public involvement are essential in decisions that impact the entire community. Instead of revisiting this issue repeatedly, we should be focusing on more pressing priorities, such as increasing library operating hours, improving literacy programs, and expanding access to educational resources for all residents.

Libraries are a cornerstone of knowledge, learning, and community support. They should be shaped by inclusive policies that represent everyone, not just those with the loudest voices. Please ensure that decisions regarding our public libraries are made with fairness, transparency, and the best interests of the entire community in mind.

Alice Hawkins, Carroll Matthews, and Dora Wilburn voted against approving the Collection Development Policy proposed by staff. After the vote, Jennifer Anderson said she did not like the policy as presented but wanted to move forward and focus on other things.
