C. Public Comment

- Jazmeyne Evans thanked people for advocating for the library and would love to see
 more transparency and accountability for the boards. There were conversations of board
 members talking to outside organizations or messaging city council. She felt that the
 library is having budget issues, but the board talked about spending money on library
 cards and proposed removing language that supports first amendment rights.
- Tom Tagliabue felt that the intergovernmental agreement with Flour Bluff School District still works. He felt that the burden for a new library should rest with the school district and that they should buy the facility at market value.
- Julie Rogers had a petition demanding more funding for the libraires. She felt that the libraries are chronically underfunded and that the board should start working on next year's budget now.
- Becky Moeller supported Julie Rogers' public comment and wants better funding.

A motion to amend the August minutes to say "A discussion was held regarding reduced hours at the Janet F. Harte Library. Board members expressed concern and urged Library staff to work with the Flour Bluff Independent School District to develop a calendar that includes additional hours for public use.

Carroll Matthews pointed out that the Library building is owned by the City of Corpus Christi. The 1998 intergovernmental agreement between Flour Bluff Independent School District and the City of Corpus Christi states that:

'Lease will be irrevocable so long as the building constructed by the City on Leased Premises is used as a branch of the City's public library system.'

'City retains sole right to cease Library operations.'" was made by Carroll Matthews and seconded by Alice Hawkins. All voted to amend except Melinda De Los Santos who arrived late. Alice Hawkins made a motion to approve the August minutes as amended; Dolores Rabon seconded the motion. All voted to approve the August minutes as amended except Melinda De Los Santos who arrived late.

Topics included background information of the program, program benefits, and the revamped journals, benefits, and celebrations.

G. Director's Report

- **4.** <u>25-1424</u> Director's Report
 - Budget-Seven budget input sessions were held. At each session public comments were made regarding library resources and materials, staffing and hours of operations. First Reading Ordinance adopting the Operating Budget is scheduled for the September 2 City Council agenda and includes amendments restoring the \$80,395 for the Harte vacant position and \$50,000 to the library's books and periodicals budget.
 - La Retama exterior renovations- A pre-construction meeting was held on August 28; a

construction kickoff meeting is tentatively scheduled for September 15.

- Teen and Young Adult shifting- 2,407 titles were reviewed. Of those, 1,425 were moved to the Teen collection and 982 remained in the Young Adult collection. The library catalog is being reviewed for consistency.
- Harte Library Town Hall Meeting- A town hall meeting was held on Monday, August 25. Councilwoman Kaylynn Paxson, City Manage Peter Zanoni, and FBISD Superintendent Chris Steinbruck were present. Approximately 80 were in attendance.
- A discussion was held regarding specifics of revisiting the public hours. Carroll Matthews pointed out that the city and FBISD discussed the hours on March 19th. Sony Peronel, assistant city manager clarified that only the pros and cons were discussed, not specific dates or hours.
