

#### Recap

## Board Actions October & November 2022

Motion to recommend extension of the term until December 31, 2042 and to add two additional board members to be appointed by City Council on the recommendation of Nueces County

Motion to recommend modification of boundaries to include all portions of Whitecap PID that were currently outside the zone

Motion to recommend modification of boundaries to include the areas recommended by Nueces County including the Packery Channel Nature Park and Padre Balli Park

Motion to recommend amending the project and financing plan to include \$2.0M for improvements to R Briscoe King Pavilion, \$36.4M for Packery Channel maintenance, \$11.5M for Whitecap preserve developer reimbursements, and \$150K for a Mobility Plan.

# City Council Actions November & December 2022

Approved ordinance to extend the term until December 31, 2042 and to add two additional board members to be appointed by City Council on the recommendation of Nueces County

Approved ordinance to modify boundaries to include all portions of Whitecap PID that were currently outside the zone
