3. <u>22-1068</u> Harbor East Park Partnership Briefing

President Trujillo referred to Item 3. Assistant City Manager Neiman Young said the purpose of this item is to present an upcoming funding request to improve the public space located between the Science and History Museum and the Port of Corpus Christi office.

Mr. Young presented the following: location for the improvements; Harbor East Project overview; gateway signage; art walk area; lounge and overlook; board walk overlook; bulk head's current and future conditions and additional bulk head improvements.

Board Members and Mr. Young discussed the following topics: safety around the walkways; gateway signage for the Harbor East Project; whether the city agreed to lease land to the Port; city has no plans to repair the bulk heads on the Port's property; whether the park will be designed to host live music; and the type of trees that will be planted at the park.
