Meeting Minutes

Parks and Recreation Advisory Committee

Wednesday, August 9, 2023

A. Call To Order/Roll Call

The meeting was called to order and a quorum was established with Duke Canchola absent.

B. Public Comment

John Weber at 609 Naples Street spoke to replacing or adding gollfcarts/ATV's that are electric instead of diesel fueled golf carts. He believes electric golf carts are more affordable, have low maintenance and zero emissions. He also spoke to the need for more tree planting, the benefits of trees and how trees have more longevity compared to built shade structures.

Barton Bailey at 4006 Green Grove Drive spoke in support of the proposal to prohibit smoking in all City parks. He believes the Resolution will send a strong message to City Council that parks should be a clean/green space for residents to enjoy healthy activities. He felt that a majority of residents do not engage in smoking and the City can be considered a non-smoking community. This type of initiative encourages healthy behaviors and can give patrons the ability to ask others around them to refrain from smoking.

Jonathan Martinez, Coalition Coordinator for Project HOPE at the Coastal Bend Wellness Foundation spoke to a proposal of a City ordinance that would prohibit engaging in smoking or vaping in any City park. He stated he has communicated with certain experts like from the MD Anderson Cancer Center and concluded that health/safety codes are not subject to State House Bill 2127. He stated the Health District supports effective public health interventions to reduce second hand smoke. He felt that Parks and Recreation Facilities encourage healthy living and smoking/exposure to second hand smoke does not help with this strategy. He stated that adding proper signage/recepticles throughout parks for enforcement/education can aid in high ordinance compliance and reduce litter and negative peer pressure with youth.

F. Unfinished Business for Discussion or Possible Action

3. <u>23-1276</u> Resolution Supporting the Prohibition of Smoking/Vaping in all Corpus Christi Parks.

Chair Mejia began discussion with a few points to consider. She mentioned that a large number of schools are closely adjacent to City parks which can encourage youth to traverse into park property to engage in smoking activities. She stated that the Committee received a letter from the Corpus Christi-Nueces County Health District supporting a resolution to prohibit smoking in City parks.

Lieutenant Kody Harrison with the Corpus Christi Police Department was in attendance and he answered Committee questions regarding enforcement through education. He felt that this type of ordinance should not be hard to enforce. Violations are not criminal and are similar to a parking ticket in which are resolved through the Municipal Court.

Continued discussion took place regarding consideration towards other open spaces like beaches/golf courses or more specifically using the term "Parkland" in the Resolution. It was clarified that some of these tyes of open spaces have their own

current ordinances allowing for enforcement. Thomas Cronnon suggested adding to the Resolution the phrase "with potential exemptions including beaches and golf courses". A motion was made by Flo East to approved the Resolution to include the suggested phrase above for potential exemptions. The motion was seconded by Twila Stevens and the motion passed unanimously.

G. New Business for Discussion or Possible Action

A motion was made by Thomas Cronnon nominating Linda Lindsey as Chair. No other nominations were presented. The motion was seconded by Flo East and the motion passed.

Discuss Food/Snack Provisions

Resolution in support of a prohibition on smoking or vaping at all Corpus Christi city parks.

WHEREAS, the use of tobacco and vaping products is addictive and remains the leading preventable cause of death in the United States;

WHEREAS, secondhand smoke is harmful to health, even outdoors;

WHEREAS, parks are frequented by children, who can be exposed to the effects of tobacco products and/or pressured by peers to try tobacco products;

WHEREAS, cigarette products are one of the most frequently found types of litter in parks and are not biodegradable;

WHEREAS, the City of Corpus Christi devotes valuable staff time to the cleanup of litter in parks, and

WHEREAS, the natural beauty and cleanliness of Corpus Christi parks and beaches is a significant part of their value.

BE IT RESOLVED BY THE PARKS AND RECREATION ADVISORY COMMITTEE OF THE CIT OF CORPUS CHRISTI, TEXAS THAT:

SECTION 1. The Parks and Recreation Advisory Committee supports the prohibition of smoking or vaping at all Corpus Christi city parks with potential exemptions including golf courses and beaches.

Type A Expansion of Allowable Uses

Today

- 1/4 Cent Sales Tax
 - Arena-1/8 cent
 - Seawall-1/8 cent
- Expiration
 - Arena-2025
 - Seawall-2026
- Revenue
 - 1/4 cent produces approximately \$17.8M annually which continues to increase each year

Type A Expansion of Allowable Uses

Proposition

- Propose 1/4 cent allocation
 - Convention Center Complex as defined by resolution
 - Regional parks as defined by resolution
 - Commercial/industrial streets (including arterials and collectors)
 - New destination flight option enhancement
- If approved, collections can be used for the specific items approved by voters without expiration or until a change is approved by voters.
- Annually Parks, Streets and the Convention Center Complex will receive a minimum of 5% of the collections. The Airport will be allocated an annual amount not to exceed 5%

Convention Center Complex will receive a minimum of 5% of the total revenue annually





Commercial and Industrial Streets

Funding will be used for street projects in support of economic development in commercial and industrial areas

- ✓ Can be used for arterials and collector streets
- X Cannot be used for residential streets

Streets will receive a minimum of 5% of the total revenue annually

Corpus Christi International Airport

Funding will be used for the attraction and support of new destinations to and from the City

- ✓ Minimum Revenue Guarantee (MRG) for new routes
- ✓ Capital improvements needed to support new routes

Airport will receive an amount up to 5% of the total revenue annually

Type A Expansion of Allowable Use

Process

- November 7, 2023 election to approve repurpose of 1/4 cent after existing debt is paid in full
- Election prior to expiration ensures no interruption in collection

Type A Expansion of Allowable Use

Proposition Ballot Language

Voters will vote "For" or "Against"

Replacing the expiring Type A sales and use taxes by adopting a sales and use tax at the rate of 1/4 of 1% (being 0.250 cents per \$1), maintaining the same sales and use tax rate that now exists within the City, with proceeds to be used for the construction, renovation, maintenance, and operations of Regional Parks (a term defined by the City of Corpus Christi, Texas Resolution Number ______), commercial/industrial streets, the Convention Center Complex (a term defined by Resolution Number ______), and new destination flight option enhancement at the Corpus Christi International Airport.
