- Tom Tagliabue welcomed the new and returning board members and encouraged greater transparency regarding Harte Library. He felt that the financial burden should go to Flour Bluff ISD since they violated the terms of the contract.
- Melinda De Los Santos encouraged the board to embrace different perspectives. She stated that the previous board members were protecting children and that sexually explicit materials lead to endangering children.
- Jesus Wong welcomed the new members and encouraged them to look to other libraries as inspiration like McAllen or San Antonio who, in his opinion, do not impose their will or fall for false narratives.

##### **3. [25-1850](#) Friends of CCPL Liaison Report**

- The Friends met in November. A new programming grant is in the works based on the book "1776". This would include a book club and would be a matching grant.
- The Friends are supporting the library with the purchase of kitchen carts for programming and are assisting in the expansion of Computer 101 classes.
- They are continuing discussions on the Discover booklets and are welcoming feedback.
- The library has applied for a grant with Pizza Hut for STEM kits that can be checked out. Staff are working on phonics kits as well. Discussion was held regarding the grant writing process and what grants need approval by City Council. Alice Hawkins asked if the public could make donations to buy kits.

- Laura gave an overview of the basic framework for board meetings.
- Bond 2022-voters approved \$2.5M for exterior improvements to La Retama Central Library, projected completion summer 2026.
- La Retama Central Library Emergency Generator- \$1.5M, projected completion summer 2026. Discussion was held regarding the timeline and reasons for delays.
- Bond 2024- voters approved \$2M for design of future Garcia Library/Senior Center Complex. Currently, the Dr. Clotilde P. Garcia Library is located in District 5 on the campus of Kaffie Middle School.
- Harte Library update- discussion was held regarding temporary options as well as permanent ones. Staff are using this school year to find a solution that will allow for full public access hours. Alice Hawkins asked for an update from the architect, Sony Peronel said that an update would come later, when options are clearer. Marilena Garza asked for an update from FBISD. Laura Garcia stated that FBISD staff had attended the September Board meeting. Carroll Matthew asked that the contract be sent to Board members. Alice Hawkins made a motion to end discussion. Carroll Matthews seconded the motion. The motion passed unanimously.
