I. CALL TO ORDER/ROLL CALL

Chairman Pruitt called the meeting to order at 4:30 pm and a quorum was established to conduct the meeting with Commissioners McLaughlin, Mumme, and Underwood being absent.

Absent: 3 - Cheryl McLaughlin, Jeff Mumme, and Clark Underwood

II. PUBLIC COMMENT: None.

III. Approval of Absences: Commissioner Wilson, Becquet, and Underwood (3.26.2026 meeting)

Chairman Pruitt stated for the record that the approval of absences would be amended on record to include his name.

Vice Chairman Landreth made a motion to approve the absence of Chairman Pruitt, Commissioners Wilson, Becquet, and Underwood from the March 26, 2026, meeting. Commissioner Riggle seconded. Vote: All Aye. Motion passes.

No updates on subcommittee currently.

Chairman Pruitt discussed old Bayview cemetery would be conducting a tour on 5.2.2026 at 10:00am. Stated he would be sending out an email to forward to the commissioners.

3. [26-0585](#) Discussion on Historical Preservation Award Nominations

Commissioner Wilson suggested making more than one nomination in the specified categories due to the number of people and/or organizations who meet the criteria for a Historical Preservation award.

Commissioner Pruitt stated there is no limit so it would be at the commission's discretion how many can be nominated to accept the award.

Buildings/Properties:

Vice Chairman Landreth stated for building category the Art Museum meets the timeframe needed for the preservation award. Commissioner Becquet stated the museum has applied for the national historical registry this year which means they meet the full criteria of award nomination.

Chairman Pruitt asked if Commissioner Becquet could make contact with the art museum staff so they can be present to receive the award if nomination goes through.

Vice Chairman Landreth made motion to nominate the Art Museum of South Texas for the 2026 Historical Preservation Award in the buildings category. Commissioner Meyer seconded. The Vote: All Aye. Motion passes.

Architects/Organizations:

Commissioner Riggle suggested architect John Wright who passed away last fall. She stated his work specialized in preservation and renovation. Some of his projects worked and designed were Harrison's Landing, the North Beach Arch, the Corpus Christi Cathedral, and the Six Points Transfer Station. Research will be done to contact his widow to be present to receive the award if nomination goes through.

Commissioner Riggle made motion to nominate John Wright for the 2026 Historical Preservation Award in the architects and organizations category. Commissioner Meyer seconded. The Vote: All Aye. Motion passes.

Education:

Commissioner Becquet stated that Dr. Mark Robbins, a Del Mar College professor, has played an integral part of education for his work in engaging students at the school on local history. She also stated Dr. Kristen Robbins just did an exhibit for Texas A & M University-Kingsville regarding the 100-year history of Kingsville.

Commissioner Wilson said the Daughters of the Republic of Texas most notably the Clara Driscoll Chapter have been an outstanding organization who continues to reach out to educate the local public schools in the area. The conduct Texas history contests in grades 4-7 for the past few decades. The focus of the education is so school aged children can have a greater appreciation for the state of Texas.

Commissioner Pruitt mentioned nominating Bill Havelka for his work on the history of South Texas. He was member of the Nueces County historical commission, Texas Archaeological Society, Friends of old Bayview cemetery, and Nueces County historical society.

Commissioner Wilson made a motion to nominate Dr. Mark Robbins, Dr. Kristen Robbins, the Daughters of the Republic Texas-Clara Driscoll Chapter, and Bill Havelka for the 2026 Historical Preservation Award in the education category. Riggie seconded. The Vote: All Aye. Motion passed.

History Books:

Chairman Pruitt made a motion to nominate Captain John Dix: A Texas Pioneer, 1796-1870 by Dan R. Manning and A Man from Corpus Christi by Dr. A.C. Peirce for the 2026 Historical Preservation Award in the history book category. Commissioner Riggie seconded. The Vote: All Aye. Motion passed.

Special Recognition-Thank You Award:

Commissioner Wilson brought up the idea of bringing up a new category to meet the criteria of students who have brought light to historical preservation. Chairman Pruitt said that if they add a new category, it would be added and introduced at the following year's historical preservation award.

Commissioner Meyer made a motion to nominate Eli Oliver for a special one-time award from the Landmark Commission. Commissioner Becquet seconded. The Vote: All Aye. Motion passes.

Upon clarification and amending the commission decided the following:

In honor of historical preservation month, the commission decided to award a special commendation award Eagle Scout Eli Oliver for his contribution to historical preservation due to his research and development on the Tracking Station Project Interpretive Panels now installed at Bill Witt Park.

Chairman Pruitt also stated that the commissioners would be in charge of the award summary to be given at the 2026 Historical Preservation Award ceremony.
