#### I. CALL TO ORDER/ROLL CALL

Chairman Pruitt called the meeting to order at 4:31 pm and a quorum was established to conduct the meeting with Commissioners Wilson, Espinoza, and Riggle absent.

#### II. PUBLIC COMMENT: None.

#### III. APPROVAL OF MINUTES: January 23, 2025.

A motion was made by Commissioner McLaughlin to approve the minutes as presented by staff, seconded by Commissioner Wanzer. The Vote: All Aye. The motion passed.

#### IV. APPROVAL OF ABSENCES: Commissioner Veronica Wilson

A motion was made by Commissioner Wanzer to approve the absence of Commissioner Wilson; it was seconded by Commissioner Landreth. The Vote: All Aye. The motion passes.

#### V. DISCUSSION AND POSSIBLE ACTION:

- **COA 601 N Water**

Mr. Kurtz gave a PPT presentation on the Certificate of Appropriateness (COA) for the Arya Hotel located at 601 North Water Street. Commissioners commented and asked questions about specific parts of the building and wanted further description/explanation. There was a lengthy discussion on where the brick extended to, the tint on the windows, and the decorative addition to the roof. Staff answered their questions satisfactorily. Mr. Kurtz Stated that he had spoken with the Texas Historical Commission (THC) about the building due to the Contemporary look of the rendering and THC stated that they were okay with the rendering with the exception of the covering of the brick arches on the ground floor. Staff recommended to approve the COA under the condition that the bricks were not completely covered but painted or stained with approved (breathable) paint or stain.

A motion was made by Commissioner McLaughlin to approve the Certificate of Appropriateness with conditions, under the staff recommendation that the brick on the ground floor arches, on Water and People's Streets, remain exposed and/or painted or stained with approved materials. Commissioner Moreno seconded the motion. The Vote:

All Ayes. The motion passed.

- **Nominees for Preservation Month**

Mr. Kurtz presented two buildings: 1103 S. Staples and 921 N. Chaparral. A short discussion took place on the award categories for Preservation Month.

Commissioner Wanzer asked when we will be voting and discussing the nominees. Staff suggested it take place during the April meeting. Discussed the sale of the Caller Times building and publicizing the winners. Local media outside of social media.
