Please be advised you must be available for the duration of the City Council Meeting as the "appeal" may be heard at any time during the regularly scheduled meeting.

NOTICE TO PERSON LISTED ABOVE AS OWNER: According to the real property records of Nueces County, you own the real property described in this notice. If you no longer own the property, you must execute an affidavit stating that you no longer own the property and stating the name and last known address of the person who acquired the property from you. The affidavit must be delivered in person or by certified mail, return receipt requested, to this office, no later than the 10th day after the date you receive this notice. If you do not send the affidavit, it will be presumed that you owned the property described in this notice, even if you did not.

When an appeal is pending, all order of the Board shall be suspended in their operation. The City Council, upon appeal, may vary the application of any provision of this code to any particular case when the enforcement thereof would do manifest injustice and would be contrary to the spirit and purpose of this code, The Corpus Christi Property Maintenance Code or public interest or when, in its opinion, the decision of the Board should be modified or reversed.

- 1.) A decision of the City Council to vary the application of any provision of this Code or the Corpus Christi Property Maintenance Code, or to modify an order of the Board in whole or in part shall

specify in what manner such modification is made, the conditions upon which it is made and the reasons therefor.

- 2.) If the decision of the City Council reverses or modifies the refusal order, or disallowance of the Board or varies the application of any provision of this code, or the Corpus Christi Property Maintenance Code, the Code Official shall immediately act in accordance with such decision.

- 3.) The decision of the City Council shall be final unless the aggrieved party appeals by instituting suit for that purpose in any court having jurisdiction within 15 days from the date on which the decision of the City Council was rendered.

You will have the opportunity to comment regarding the property during the appeal proceedings.
