- 3. <u>17-0227</u> Funding Approval for Park Road 22 Bridge

Motion amending the Tax Increment Reinvestment Zone #2 City of

Corpus Christi Project Plan to add the following sentence after the seventh paragraph: "A project consisting of the construction of two bridges on Park Road 22 is added in the February 28, 2017, amendment;" and amending the Tax Increment Reinvestment Zone #2 City of Corpus Christi Financing Plan to add the following paragraph at the end of the section called Improvements in Other Areas within TIRZ #2: "One improvement to the TIRZ #2 is the construction of two bridges on Park Road 22 between Commodores and Whitecap. The bridges will require up to \$4,000,000 of TIRZ #2 funding and will allow for travel over canals that are to be built by a third party developer in the area."

4. <u>17-0228</u> Packery Channel Monitoring Continuation

Motion recommending that City Council approve a five year Master Services Agreement between the City of Corpus Christi and Texas A & M University - Corpus Christi (TAMU-CC) for Packery Channel Monitoring in an amount not to exceed \$2,000,000 and authorize Task Order #1 in the amount of \$257,745; appropriating \$257,745 from the unreserved fund balance of Fund 1111 "Reinvestment Zone No. 2 Fund; changing the Fiscal Year 2017 operating budget for Fund 1111 "Reinvestment Zone No. 2 Fund" by increasing expenditures by \$257,745; and amending the Tax Increment Reinvestment Zone #2 Financing Plan by adding the following sentence at the end of the paragraph that discusses Yearly Miscellaneous Improvements for the Packery Channel: "These Yearly Miscellaneous Improvements specifically include routing, monitoring, and surveys of the Packery Channel and the Gulf beach."

5. <u>17-0229</u> Update Engineering Project List in the Tax Increment Reinvestment Zone #2 Project and Financing Plans

Motion amending the Tax Increment Reinvestment Zone #2 Project and Financing Plans by replacing Exhibit H with the document entitled Projects with Funds from Tax Increment Reinvestment Zone #2, which contains the current information as of February 21, 2017.
