#### Background



- Prior to COVID-19 process
- During the pandemic
- As of January 3, 2022, there are 3,604 people who have a total of 10,713 city ordinance violations pending to be scheduled
- Violations involve people who were previously scheduled to both in-person and virtual dockets and failed to appear, as well as new violations scheduled for first time
- Since November 29, 2021, City Manager Peter Zanoni and the Chair of Municipal Court Committee, Council Member John Martinez, have met four (4) times with Judge Gail Loeb and Municipal Court staff to discuss the strategy to address the ordinance backlog



#### Municipal Court – Judicial Staffing




- Current Judicial Staffing
  - Six (6) full-time judges:
    - Five (5) of the six are day-time judges
    - One (1) of the six works nights
  - Seven (7) part-time judges work weekends and holidays






## Increase in Number of People with Ordinance Violations





## Increase in the Three Most Common Code Violations








### Increase in the Three Most Common Animal Violations







## Plan for Addressing Ordinance Violations



- Current pending cases to be scheduled or rescheduled as of January 4, 2022:
  - Cases to schedule: 10,713
  - Number of people: 3,604
  - Main violations involve Code Compliance and Animal Control cases. Also included are park curfew, unlawful use of utilities, fireworks in city limits, etc.



# Plan for Addressing Ordinance Violations January 18 – 21, 2022



- January In-person Ordinance Pre-trials:
  - Will be held at the American Bank Center
  - January 18, 2022, through January 21, 2022
  - Total scheduled 1,680 people
  - Arrest warrants will be issued when someone fails to appear
