FY 2022-2026 IMP Amendments



Ordinance amending the FY2022-2026 Infrastructure Management Plan to account for the repurposing of unused bond funds from Bond 2008, Bond 2012 and Bond 2016 and identifying new and revised street projects as shown in the amended FY 2022-2026 Infrastructure Management Plan.



FY 2023

RSRP Amendments



- \$4.49 M in unspent Streets Bond 2008, Bond 2012, and Bond 2016 capital funds reconciled and appropriated to the Residential Street Reconstruction Program (RSRP) via Ordinance 032686 passed on March 8, 2022.
- Accelerates a total of 15 FY 2024-2026 Residential Street Reconstruction projects to the FY 2023 RSRP. Construction anticipated to begin in March 2023.
- Advances a total of 4.34 lane miles of Residential Street Reconstruction citywide.



FY 2022 & 2023

SPMP Amendments



- Delays one (1) FY 2022 SPMP project known as "Lawrence Street & T-Head Loop from Mesquite to T-Head Loop" to the FY 2023 SPMP
- Accelerates one (1) FY 2023 SPMP project known as "Peoples Street & T-Head Loop from Lower Broadway to T-Head Loop" to the FY 2022 SPMP
- Swapping projects due to the construction schedule of the Marina's capital project (#21026), "Marina Piers A, B, C, D & L Replacement" Project



FY 2022 & 2025

In-House Amendments



- Delays two (2) FY 2022 In-House Pavement Rehabilitation projects known as "Buford from Staples to Shoreline" and "Furman from Staples to Shoreline" to the FY 2025 In-House Pavement Rehabilitation Program
- Accelerates one (1) FY 2025 In-House Pavement Rehabilitation project known as "Haven from Warrior to Violet Rd" to the FY 2022 In-House Pavement Rehabilitation Program
- Swapping projects by way of concurrence due to the district community's overwhelming support for the advancement of the Haven Street project
