



Issue

- There is a redundancy of emergency services provided to residents of Flour Bluff and North Padre Island by the City of Corpus Christi and Nueces County Emergency Services District #2.
- As a result, residents located in Flour Bluff and North Padre Island are subject to redundant taxation.
- Additionally, Nueces County ESD #2 cannot provide a full fire alarm response or EMS response on a 24/7/365 basis.

City of Corpus Christi Proposal

1. Removal of ESD #2 Territory located within Corpus Christi City Limits, thereby eliminating redundant taxation.
2. Agreement between NCESD #2 and City of Corpus Christi for pass through of ESD #2 Tax Revenue to City of Corpus Christi for Fire Protection and EMS services in remaining ESD territory (King Ranch Area).
3. Addition of 7 Firefighter Positions, pending completion of a modified Fire Academy and Paramedic Certification, and Chapter 143 Eligibility.
 - 2 Civilian Positions will also be added for training/consultation.
4. Sale of ESD #2 Real Property and Equipment to City of Corpus Christi. Redundant or excess equipment may also be sold to satisfy liabilities of the ESD.

CCFD is also acutely cognizant of the community affection for NCESD #2 and will ensure to continue on with community traditions and outreach.

Interlocal Agreement Between the City of Corpus Christi and Nueces County Emergency Services District #2 for Removal of Territory, Consolidation and the Provision of Fire and Emergency Medical Services

This AGREEMENT FOR PROVIDING EMERGENCY SERVICES ("Agreement"), effective as of February 1, 2023 ("Effective Date"), by and between NUECES COUNTY EMERGENCY SERVICES DISTRICT NO. 2 ("District"), a political subdivision of the State of Texas organized and operating pursuant to the provisions of Section 48-e, Article III of the Texas Constitution and Chapter 775 of the Health and Safety Code, as amended ("H&S Code"), and the CITY OF CORPUS CHRISTI ("City"), a Texas home-rule municipality duly organized and operating under the laws of the State of Texas.

RECITALS

WHEREAS, The District was formed as Nueces County Rural Fire Prevention District #2 in 1960.

WHEREAS, the City of Corpus Christi annexed the areas encompassing Flour Bluff in 1961, 1963, and 1974.

WHEREAS, the District desires to remove areas from its territory which are located within the City Limits and sell equipment used to service this area to the City.

WHEREAS, the City seeks to provide positions within the Corpus Christi Fire Department to current employees of the District subject to certain requirements.

WHEREAS, the District is a duly organized emergency services district, and a political subdivision of the State of Texas, created to protect life and health, and for such other purposes as determined by the District under Chapter 775 of the H&S Code, with full authority to carry out the objects of its creation; and

WHEREAS, pursuant to Section 775.031 of the H&S Code, the District has the authority to enter into contracts with others, including volunteer fire organizations, for fire protection and other services within the District; and

WHEREAS, the District desires to secure fire protection and emergency medical response services ("Emergency Services," hereinafter defined) for the geographic area of the District to be served by the Department ("Service Area," hereinafter defined); and

NOW, THEREFORE, for and in consideration of the premises and mutual covenants hereinafter contained, the parties hereto agree each with the others as follows:
