#### **Botanical Gardens**

- Grant: \$89,000 approved by City Council in July 21, 2020
- Start construction by September 1, 2020
- Received TPW Recreation Trails grant of \$200,000
- Expires: 08/21/23





#### **Del Mar College Process Technology II**

- Addition to the Process Technology plant
- Grant: \$2,356,000 approved by City Council in August 2018
- Grant paid: \$2,295,385
- Grant remaining: \$53,415
- Expires: 08/21/23
- Is operational
- They have 600 enrolled and 261 graduates





#### **Next Sports Company**

- Grant of \$1,850,000 was signed on October 23, 2020
- Agreement was amended January 23, 2021 to allow owners more time to complete financing of the project
- Must complete construction by November 30, 2023
- Owner purchased an additional acreage adjacent to the site for parking and cleared land
- Working with Development Services to get permitting to start construction
- Having problems with supply chain.



#### **International Consulting Engineers (ICE)**

- Engineering firm
- Grant: \$125,000 approved by City Council May 2018
- Grant paid: \$75,000
- Grant remaining: \$25,000
- Expires: 05/12/23
- The construction is complete \$1,422,850





# Texas A&M University – Corpus Christi Industrial and Civil Engineering

- Build out laboratory spaces for two new engineering curricula
- Grant: \$2,000,000
- Amended in August 2018 to extend the time by two years since it was not funded by the legislature and there was a delay with the Higher Education Board approval.
- Approved for both programs by Higher Education Board
- Grant paid: \$1,122,953
- Grant remaining: \$877,047
- Expires: 12/31/23
- 39 students in both curricula and 397 in pre-engineering
- Should be expensed in the next two years





#### **Texas A&M University – Lone Star UAS Center**

- Grant: \$4,000,000
- Beyond-Visual-LOS Study (\$250,000)
- Second Mission Control (\$2.13 million)
- Supporting Centers (\$1.62 million)
- Grant paid: \$119,092
- Grant remaining: \$3,880,908
- Expires: 10/18/28





#### **LaVista Pointe (Type B grant)**

- Infrastructure improvement on North Beach for apartment complex
- Grant: \$625,000
- Have COO's on all apartment buildings have started leasing apartments
  - Have 159 apartments and 129 are leased
- Construction is complete except the chapel and restaurant
- Grant paid: \$625,000
- Grant remaining: \$0
- Expires: 11/27/23

#### **Service Corps of Retired Executives (SCORE)**

## **Small Business Internship Program - Performance Results**

#### **Quarterly (October-December 2022)**

This quarter, the SBIP has supported **21** student internships, partnered with **15** local Corpus Christi small businesses, and has created **2** permanent jobs.

#### 2022

This year, the SBIP has supported **33** student internships, partnered with **19** local Corpus Christi small businesses, and has created **7** permanent jobs allowing us to retain our talented Del Mar graduates in the Corpus Christi area.

Continued support to the Del Mar College SBIP by the Corpus Christi Business and Job Development Corporation Type B Board will ensure the SBIP continues to provide invaluable assistance and resources to the small business community in Corpus Christi.




#### **Del Mar College PTAC Procurement Technical Assistance Center**

## Brief on the CRC local economic impact:

The Del Mar College Contractor Resource Center (CRC) continues to see significant growth in the 2022 Fiscal Year. The CRC has assisted 99 clients and held 381 client sessions which resulted in 41 contracts awarded totaling \$3,562,021.00 with 30 jobs created and 114 jobs retained. Compared to the 2021 fiscal year, the CRC increased their client number by 160% and increased their client sessions by 343%.

In July 2022, the CRC began emailing a weekly LEADS list to their clients which consists of local commercial projects in the planning, bidding and post bid stages obtained from ConstructConnect®, a construction software bid tool that CRC offers as a benefit of becoming a client. Within this software, a client can view project information as well as contact information for commercial projects in all stages within the Nueces County area. As a result, the CRC has held 99 ConstructConnect® client sessions, a 182% increase since last year.

Another perk the CRC offers to their clients is the opportunity to use our plan room to print plans. Every month each client can print 50 pages of plans at no-cost followed by \$1 per page thereafter. The CRC provided a total of 2,580 pages of commercial plans between 170 projects for 26 clients.

The CRC continues to provide training events/webinars on preparing small businesses to become better qualified for large commercial projects. The CRC has held 44 training events with a total of 89 attendees. We have collaborated with the Coastal Bend Innovation Center / Cheniere Energy for promoting, creating network opportunities for our clients and by participating in the "Doing Business with Giants" event. The CRC was able to be part of the planning team for the Gulf Coast Growth Ventures, "How to do business with GCGV/Exxon" procurement event held in September. The CRC held 43 counseling sessions with 34 unique clients to prepare them for one-on-one meetings with a procurement officer from GCGV/Exxon.

Moving forward, CRC will continue the rapport building with GCGV/Exxon and Cheniere Energy for business opportunities for our clients. CRC staff will also continue to market the program by outreach in the community, participating in presentations with civic organizations, chamber events, attending REDC breakfasts, and ensuring a connection with the San Patricio REDC for more awareness in the community
