## **Extension of Fiscal Year and Recommendation of Amended Budget**

## **CAPTION:**

Resolution recommending amending the Reinvestment Zone Number Two, City of Corpus Christi, FY 2013-2014 Budget adopted by Resolution on October 22, 2013, to extend fiscal year 2013-2014 by two months, increasing revenues by \$34,018 and expenditures by \$1,095,157 in Special Revenue Fund Reinvestment Zone No. 2 Fund No. 1111 as recommended by the Board of Directors North Padre Island Development Corporation; and recommending approval and adoption by City Council.

#### **PURPOSE:**

The purpose of this item is to approve the revision and two month extension of the Fiscal Year 2013-2014 Reinvestment Zone Number Two, City of Corpus Christi, FY 2013-2014 Budget and to provide a recommendation to the City of Corpus Christi City Council for their approval.

## **BACKGROUND AND FINDINGS:**

On January 21, 2014 the City of Corpus Christi City Council approved Ordinance Number 030066 changing the City's fiscal year from August 1<sup>st</sup> through July 31<sup>st</sup> to October 1<sup>st</sup> through September 30<sup>th</sup>. The Board of Directors of the Tax Reinvestment Zone No. 2 (TIRZ) must review, approve and recommend City Council approval of the revised budget and new fiscal year to facilitate the change in the City of Corpus Christi's fiscal year.

The change in the new fiscal year requires an extension of two months in the current fiscal year to facilitate the change. Due to the timing of the yearly debt service payment in the month of August, there will now be two debt service payments in Fiscal Year 2013–2014. The revised Reinvestment Zone Number Two, City of Corpus Christi, FY 2013-2014 budget must now be amended to accommodate for this second payment in the extended fiscal year.

## **OTHER CONSIDERATIONS:**

After recommendation and approval by the Board of Directors of the TIRZ, the City Council will consider and vote on an ordinance amending the Fiscal Year 2013-2014 Operating Budget which includes the Special Revenue Reinvestment Zone No. 2 Fund No. 1111. The City Council had the first reading of this ordinance on March 25, 2013.
