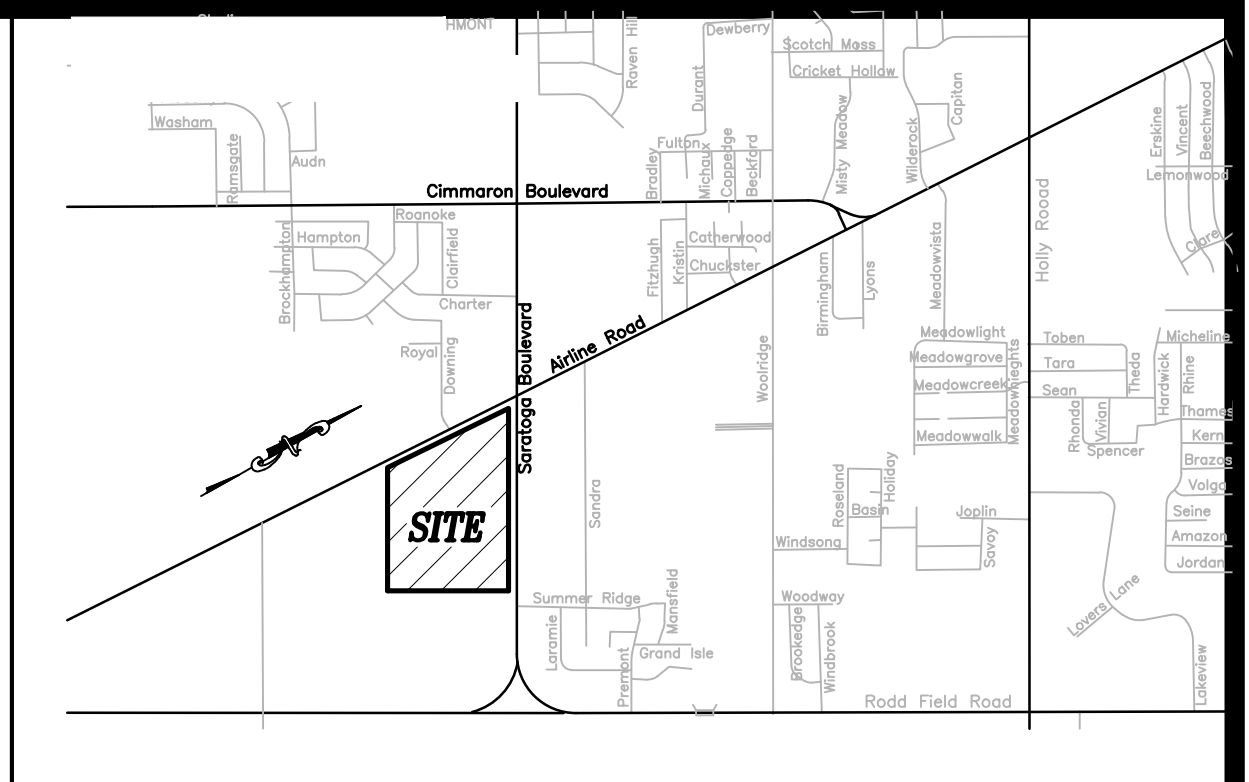
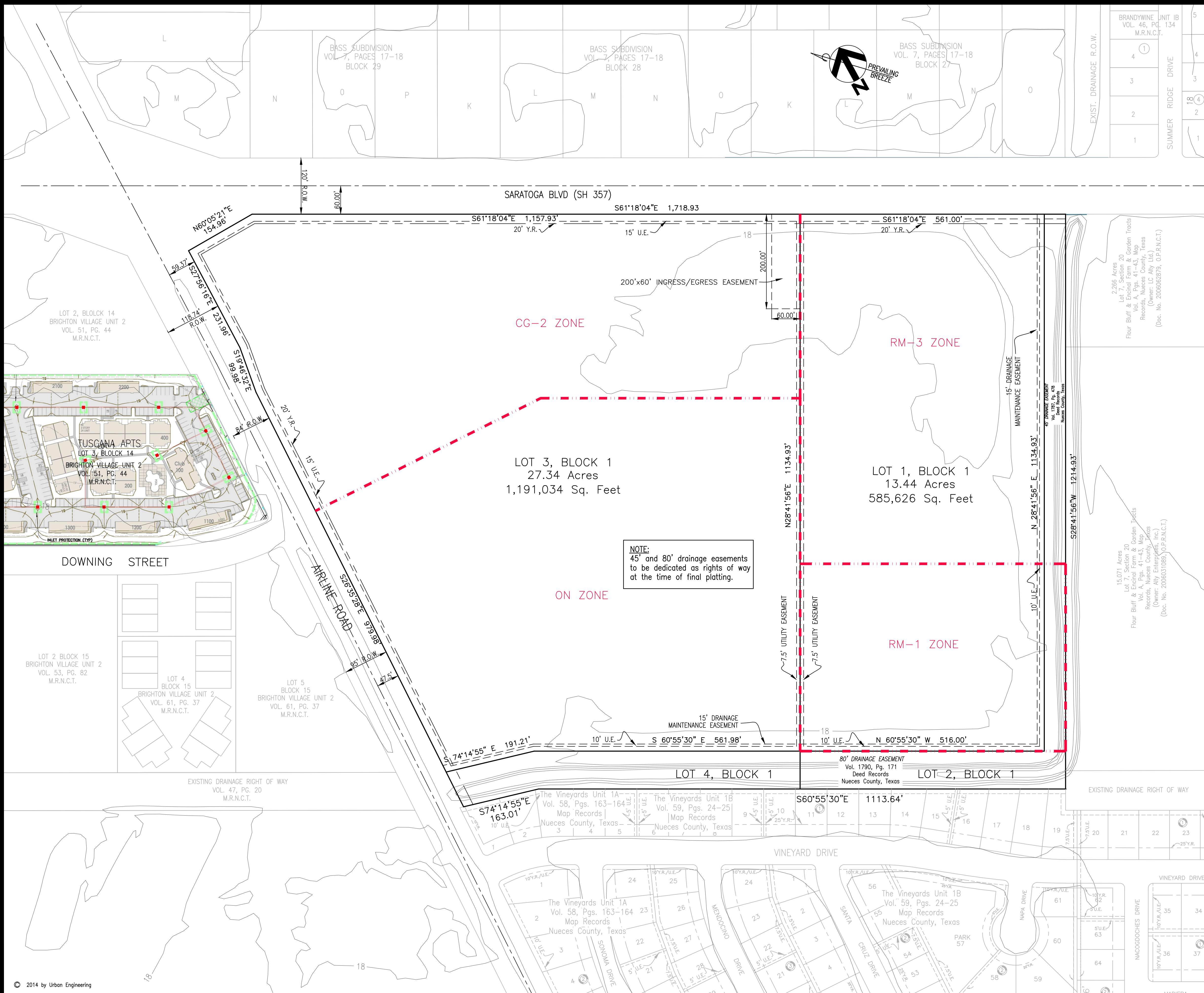

Notes:

1. Total area contains 44.34 acres of land.
2. Property is zoned CG-2, ON, RM-3 and RM-1 as labeled.
3. The receiving water for the storm water runoff from this property is the Oso Bay. The TCEQ has classified the aquatic life use for the Oso Bay as "exceptional" and "oyster waters". The TCEQ also categorized the receiving water as "contact recreation" use.
4. This development meets the City's master drainage plan and the proposed drainage will not adversely affect the drainage pattern or design of the adjacent properties.
5. There are no known natural water bodies, jurisdictional wetlands, endangered species habitat, State of Texas Submerged Lands, or critical dunes on the site.
6. By graphic plotting only, this property is in Zone "C" on Flood Insurance Rate Map, Community Panel No. 485494 0540 C, Nueces County, Texas, which bears an effective date of March 18, 1985 and Insurance Rate Map, Community Panel No. 485464 0315 D, City of Corpus Christi, Texas which bears an effective date of August 3, 1989 and it is not located in a Special Flood Hazard Area.

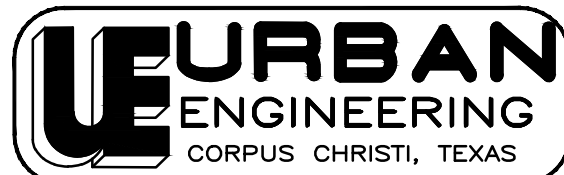
