Grant for Texas A&M University - Corpus Christi

## **CAPTION**:

Motion to approve a job training grant in the amount of \$2,000,000 to Texas A&M University-Corpus Christi related to engineering training.

## **PURPOSE:**

Texas A&M University – Corpus Christi (TAMU-CC) has submitted a request for a \$2 million grant to expand their engineering program to include electrical engineering, civil engineering, and industrial engineering.

#### **BACKGROUND AND FINDINGS:**

In 2009 the Type A Board granted TAMU-CC \$1,000,000 to start their mechanical engineering program. The University used the grant to outfit laboratories for the new program. The program was estimated to have 150 students by year three. They have just completed year three and their enrollment is 300 students. Partly because of this program, TAMU-CC was successful in their bid to become one of six FAA UAS Centers in the nation.

This expansion is another milestone along the path of TAMU-CC offering engineering training for local jobs and impact the local economy as much as \$15 million over five years
