Motion to de-obligate \$25,000 from MotorGlobe to the Type A Fund 1140 for 2014

#### PURPOSE:

De-obligate funds from large project and return to the Type A fund 1140.

## **BACKGROUND AND FINDINGS:**

The Board passed the 2014 budget on June 17, 2013 that included \$125,000 for MotorGlobe.

In March 2014 the company was not in compliance with the first year requirements of the agreement and was not eligible for the first payment of \$25,000. This payment cannot be earned later in the agreement and should be de-obligated.

This will allow the Board to use this \$25,000 for other projects.
