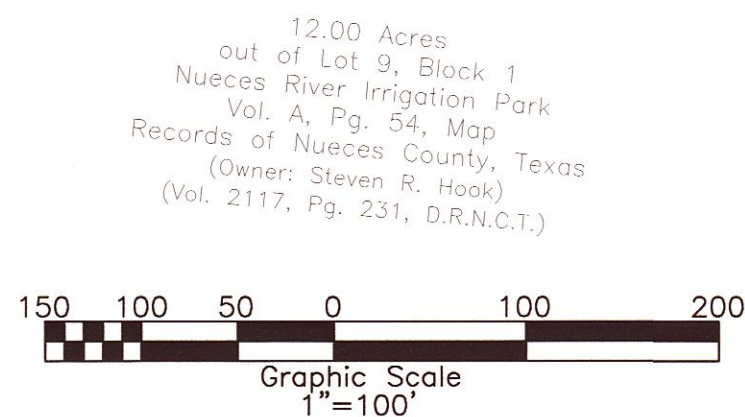
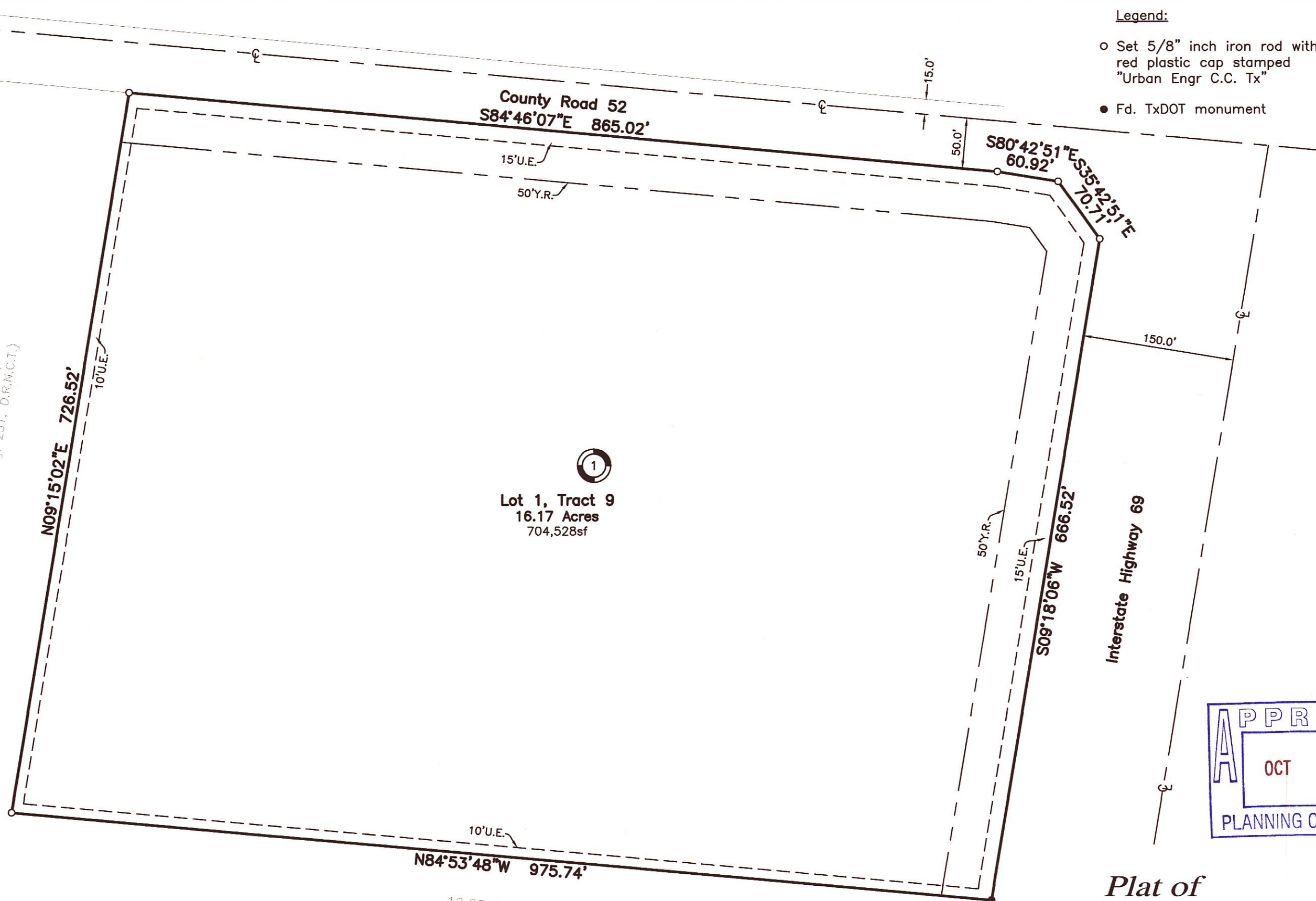

- 1.) Total platted area contains 16.17 acres of land.
- 2.) The receiving water for the storm water runoff from this property is the Nueces River upstream of the Calallen Salt Water Intrusion Dam located 1.1 miles from Nueces Bay. The TCEQ has classified the aquatic life use for this segment of the Nueces River as "high". TCEQ also categorized the Nueces River as "contact recreation" use. Additional water quality protection measures must be observed for this receiving water due to the TCEQ designation as a "public water supply".
- 3.) Bearings based on GPS, NAD83, State Plane Coordinates, Texas South Zone 4205.
- 4.) By graphic plotting only, this property is in Zone "C" on Flood Insurance Rate Map, Community Panel No. 485494 0257 C, Nueces County, Texas, which bears an effective date of March 18, 1985 and is not in a Special Flood Hazard Area.
- 5.) Subdivider shall provide water service connection.
- 6.) Subdivider shall provide sanitary sewer connection or septic system.
- 7.) Minimum finished floor elevation shall not be less than 12 inches above the centerline of the facing street unless otherwise noted by the engineer of record.
- 8.) Property must comply with TxDOT's Traffic Access Management Plan.
