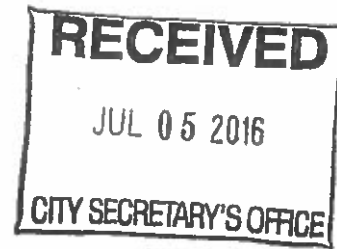

Sec. 53-297. - Imposition of civil penalty for creating dangerous intersections.



- (a) The city council finds and determines that a vehicle that proceeds into an intersection when the traffic control signal for the vehicle's direction of travel is emitting a steady red signal damages the public by endangering motor vehicle operators and pedestrians alike, by decreasing the efficiency of traffic control and

traffic flow efforts, by increasing the number of serious accidents to which public safety agencies must respond at the expense of the taxpayers, and is operated in violation of the instructions of that traffic-control signal.

- (b) Except as provided in subsection (c) of this section, the owner of a motor vehicle is liable for a civil penalty of seventy-five dollars (\$75.00) if the motor vehicle proceeds into an intersection at a system location when the traffic control signal for that motor vehicle's direction of travel is emitting a steady red signal, as specified by Texas Transportation Code Section 544.007(d).
