Affordable Housing – Homebuyer Assistance Program Agreement for April 1, 2017 through March 31, 2018

CAPTION:

Motion transferring \$220,000 in Fund 1140 Economic Development Fund from the Affordable Housing's "Available for Projects" balance to the Affordable Housing's "Homebuyer Assistance Program" balance in the amount of \$200,000 and to the Affordable Housing's "City of Corpus Christi – Reimbursement" balance in the amount of \$20,000 to reimburse the City for staff time in implementing the Program; and authorizing the president to execute an affordable housing services agreement with the City's Housing and Community Development Department.

PURPOSE:

Transferring funding for Type A Affordable Housing Program's Homebuyer Assistance Program in order to continue to assist qualified homebuyers with up \$10,000 in down payment assistance for the purchase of a new or pre-existing home. City staff will be reimbursed no more than \$20,000 for time spent on implementing the Program within the one (1) year period.

BACKGROUND AND FINDINGS:

The City of Corpus Christi's Housing and Community Development receives funding to provide certain programs from the Type A Board and City Council. These funds will be transferred for the support of the Homebuyer Assistance Program which assists qualified homebuyers with up to \$10,000 in down payment assistance for the purchase of a new or pre-existing home. The Agreement is for a one (1) year term of April 1, 2017 to March 31, 2018. It is anticipated that with the funding support of \$200,000, the Housing and Community Development Department will assist over households at up to \$10,000 each household for down payment assistance. The City anticipates that no more than \$20,000 will be required to be reimbursed for City staff time spent on implementing the Program within the one (1) year period.

Additionally, this agreement adds a provision regarding the reporting in which HCD staff will provide the Type A Board with Quarterly updates following the end of each quarter which will include:

- the number of loans processed
- the number of applicants

- the number of hours spent reviewing and processing loan applications during the preceding quarter
- the termination of the Agreement by giving at least 30 days' written notice of either party's intent to terminate
